## A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2006 – Prince George’s County**  
3 **– New Revival Center of Renewal – Reauthorization**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2006  
5 to change the location of the New Revival Center of Renewal to Prince George’s  
6 County; and extending the deadline for the grantee to present evidence that a  
7 matching fund will be provided.

8 BY repealing and reenacting, with amendments,  
9 Chapter 46 of the Acts of the General Assembly of 2006, as amended by Chapter  
10 219 of the Acts of the General Assembly of 2008  
11 Section 1(3) Item ZA01(CA) and ZA02(BU)

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
13 MARYLAND, That the Laws of Maryland read as follows:
