CHAPTER _____

1 AN ACT concerning

2 **Annual Curative Bill**

3 FOR the purpose of generally curing previous Acts of the General Assembly with
4 possible title defects; prohibiting the Dorchester County Board of License
5 Commissioners from approving the transfer of a certain license issued on or
6 before a certain date; authorizing the Mayor and City Council of Baltimore City
7 or the governing body of a county or municipal corporation to grant a certain
8 property tax credit for certain residential real property owned by a disabled
9 correctional officer or the surviving spouse of a certain fallen correctional officer;
10 providing for the effect and construction of certain provisions of this Act;
11 making this Act an emergency measure; and generally repealing and reenacting
12 without amendments certain Acts of the General Assembly that may be subject
13 to possible title defects in order to validate those Acts.

27 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
28 MARYLAND, That the Laws of Maryland read as follows:

29 **Article 2B – Alcoholic Beverages**

30 5–201.

31 (k) (4) The Dorchester County Board of License Commissioners may not
32 approve the transfer of a Class B (on–sale and off–sale) beer and light wine license
33 issued on or before June 30, 2008.

2 (a) No more than one license provided by this article, except by way of
3 renewal or as otherwise provided in this section, shall be issued in any county or
4 Baltimore City, to any person, or for the use of any partnership, corporation,
5 unincorporated association, or limited liability company, in Baltimore City or any
6 county of the State, and no more than one license shall be issued for the same
7 premises except as provided in §§ 2–201 through 2–208, 2–301, and 6–701 of this
8 article, and nothing herein shall be construed to apply to § 6–201(r)(4), (15), and (17), §
9 7–101(b) and (c), § 8–202(g)(2)(ii) and (iii), § 8–508, or § 12–202 of this article.

16 (11) (i) “Electronic communication” means any transfer of signs,
17 signals, writing, images, sounds, data, or intelligence of any nature transmitted in
18 whole or in part by a wire, radio, electromagnetic, photoelectronic, or photooptical
19 system.

20 (ii) “Electronic communication” does not include:

- 21 1. Any wire or oral communication;
- 22 2. Any communication made through a tone-only paging
23 device; or
- 24 3. Any communication from a tracking device.

31 Part VI. Registration, Enforcement, and Modification of Support Order.

1 10-340.

2 A support order or income withholding order issued by a tribunal of another
3 state may be registered in this State for enforcement.

8 **Article – Natural Resources**

9 8-1802.

10 (a) (13) (i) “Intensely developed area” means an area of at least 20
11 acres or the entire upland portion of the critical area within a municipal corporation,
12 whichever is less, where:

13 1. Residential, commercial, institutional, or industrial
14 developed land uses predominate; and

15 2. A relatively small amount of natural habitat occurs.

16 (ii) “Intensely developed area” includes:

17 1. An area with a housing density of at least four
18 dwelling units per acre;

19 2. An area with public water and sewer systems with a
20 housing density of more than three dwelling units per acre; or

21 3. A commercial marina redesignated by a local
22 jurisdiction from a resource conservation area or limited development area to an
23 intensely developed area through a mapping correction that occurred before January
24 1, 2006.

25 (14) “Land classification” means the designation of land in the
26 Chesapeake Bay Critical Area or Atlantic Coastal Bays Critical Area in accordance
27 with the criteria adopted by the Commission as an intensely developed area or district,
28 a limited development area or district, or a resource conservation area or district.

29 (15) (i) “Limited development area” means an area:

30 1. That is developed in low or moderate intensity uses
31 and contains areas of natural plant and animal habitat; and

1 (ii) "Program" includes any amendments to the program.

2 (19) (i) "Program amendment" means any change or proposed
3 change to an adopted program that is not determined by the Commission chairman to
4 be a program refinement.

5 (ii) "Program amendment" includes a change to a zoning map
6 that is not consistent with the method for using the growth allocation contained in an
7 adopted program.

8 (20) (i) "Program refinement" means any change or proposed change
9 to an adopted program that the Commission chairman determines will result in a use
10 of land or water in the Chesapeake Bay Critical Area or the Atlantic Coastal Bays
11 Critical Area in a manner consistent with the adopted program, or that will not
12 significantly affect the use of land or water in the critical area.

13 (ii) "Program refinement" may include:

14 1. A change to an adopted program that results from
15 State law;

16 2. A change to an adopted program that affects local
17 processes and procedures;

18 3. A change to a local ordinance or code that clarifies an
19 existing provision; and

20 4. A minor change to an element of an adopted program
21 that is clearly consistent with the provisions of this subtitle and all of the criteria of
22 the Commission.

23 (21) (i) "Project approval" means the approval of development, other
24 than development by a State or local government agency, in the Chesapeake Bay
25 Critical Area or the Atlantic Coastal Bays Critical Area by the appropriate local
26 approval authority.

27 (ii) "Project approval" includes:

28 1. Approval of subdivision plats and site plans;

29 2. Inclusion of areas within floating zones;

30 3. Issuance of variances, special exceptions, and
31 conditional use permits; and

32 4. Approval of rezoning.

33 (iii) "Project approval" does not include building permits.

1 (22) (i) “Resource conservation area” means an area that is
2 characterized by:

3 1. Nature dominated environments, such as wetlands,
4 surface water, forests, and open space; and

5 2. Resource-based activities, such as agriculture,
6 forestry, fisheries, or aquaculture.

7 (ii) “Resource conservation area” includes an area with a
8 housing density of less than one dwelling per five acres.

9 (23) “Tributary stream” means a perennial stream or an intermittent
10 stream within the critical area that has been identified by site inspection or in
11 accordance with local program procedures approved by the Commission.

18 **Article – Tax – Property**

19 9–210.

20 (a) (1) In this section the following words have the meanings indicated.

21 (2) “Disabled law enforcement officer or rescue worker” means an
22 individual who:

23 (i) has been found to be permanently and totally disabled by an
24 administrative body or court of competent jurisdiction authorized to make such a
25 determination; and

26 (ii) became disabled:

27 1. as a result of or in the course of employment as a law
28 enforcement officer or a correctional officer; or

29 2. while in the active service of a fire, rescue, or
30 emergency medical service, unless the disability was the result of the individual’s own
31 willful misconduct or abuse of alcohol or drugs.

1 (3) (i) “Dwelling” means real property that:

2 1. is the legal residence of a disabled law enforcement
3 officer or rescue worker or a surviving spouse; and

4 2. is occupied by not more than two families.

5 (ii) “Dwelling” includes the lot or curtilage and structures
6 necessary to use the real property as a residence.

7 (4) “Fallen law enforcement officer or rescue worker” means an
8 individual who dies:

9 (i) as a result of or in the course of employment as a law
10 enforcement officer or a correctional officer; or

11 (ii) while in the active service of a fire, rescue, or emergency
12 medical service, unless the death was the result of the individual’s own willful
13 misconduct or abuse of alcohol or drugs.

14 (5) “Surviving spouse” means a surviving spouse, who has not
15 remarried, of a fallen law enforcement officer or rescue worker.

16 (b) The Mayor and City Council of Baltimore City or the governing body of a
17 county or municipal corporation may grant, by law, a property tax credit under this
18 section against the county or municipal corporation property tax imposed on a
19 dwelling that is owned by a disabled law enforcement officer or rescue worker or a
20 surviving spouse of a fallen law enforcement officer or rescue worker:

21 (1) if the dwelling was owned by the disabled law enforcement officer
22 or rescue worker at the time the law enforcement officer or rescue worker was
23 adjudged to be permanently and totally disabled or by the fallen law enforcement
24 officer or rescue worker at the time of the fallen law enforcement officer’s or rescue
25 worker’s death;

26 (2) if the disabled law enforcement officer or rescue worker was
27 domiciled in the State as of the date the disabled law enforcement officer or rescue
28 worker was adjudged to be permanently and totally disabled or the fallen law
29 enforcement officer or rescue worker or the surviving spouse was domiciled in the
30 State as of the date of the fallen law enforcement officer’s or rescue worker’s death and
31 the dwelling was acquired by the disabled law enforcement officer or rescue worker
32 within 2 years of the date the disabled law enforcement officer or rescue worker was
33 adjudged to be permanently and totally disabled or by the surviving spouse within 2
34 years of the fallen law enforcement officer’s or rescue worker’s death; or

35 (3) if the dwelling was acquired after the disabled law enforcement
36 officer or rescue worker or the surviving spouse qualified for a credit for a former
37 dwelling under item (1) or (2) of this subsection, to the extent of the previous credit.

1 (c) A county or municipal corporation may provide, by law, for:

2 (1) the amount and duration of a property tax credit allowed under
3 this section; and

4 (2) any other provision necessary to carry out the provisions of this
5 section.

11 **Article – Transportation**

12 13–619.1.

13 (a) (1) The owner of a motor vehicle, or a lessee of the vehicle under a
14 lease not intended as security, or a director, officer, employee, or partner of a business
15 entity that owns the vehicle may apply to the Administration for the assignment of a
16 special registration number and special registration plates under this section for a
17 vehicle included in one of the following classes:

18 (i) A Class A (passenger) vehicle;

19 (ii) A Class E (truck) vehicle with a one ton or less
20 manufacturer's rated capacity;

21 (iii) A Class M (multipurpose) vehicle; or

22 (iv) A Class D (motorcycle) vehicle.

23 (2) To be eligible for a special registration described under subsection
24 (c)(2)(i) of this section, an applicant shall provide proof that is satisfactory to the
25 Administration that the applicant is a recipient of an individually earned,
26 combat-related, armed forces medal.

27 (3) To be eligible for a special registration described under subsection
28 (c)(2)(ii) of this section, an applicant shall provide proof that is satisfactory to the
29 Administration that the applicant is an honorably discharged veteran of a branch of
30 the armed forces of the United States.

31 (4) To be eligible for a special registration described under subsection
32 (c)(2)(iii) of this section, an applicant shall provide proof that is satisfactory to the

1 Administration that the applicant is a recipient of the U.S. Department of Defense
2 Gold Star for surviving spouses, parents, and next of kin of members of the armed
3 forces who lost their lives in combat.

4 (b) (1) In addition to the annual registration fee otherwise required under
5 this title, an owner of a vehicle assigned a special registration under this section shall
6 pay a fee as determined by the Administration each time new registration plates are
7 issued for the vehicle. The fee shall be calculated to recover the costs incurred by the
8 Administration in carrying out the provisions of this section.

9 (2) The additional fee charged under this section shall be retained by
10 the Administration for the purpose of recovering the Administration's costs under this
11 section, and may not be credited to the Gasoline and Motor Vehicle Revenue Account
12 for distribution under § 8-403 or § 8-404 of this article.

13 (c) Special registration plates issued under this section:

14 (1) May consist of any combination of letters, numerals, or both; and

15 (2) Shall include:

16 (i) For registration plates issued for an applicant described in
17 subsection (a)(2) of this section:

18 1. An emblem or logo as authorized by the
19 Administration that depicts the applicant's armed forces medal; and

20 2. Except on plates issued for Class D (motorcycle)
21 vehicles, words describing the medal printed across the bottom of the plates;

22 (ii) Words or an emblem or logo indicating that the special
23 registration plate holder is an honorably discharged veteran of a branch of the armed
24 forces of the United States; or

25 (iii) An emblem or logo indicating that the registration plate
26 holder is the recipient of the U.S. Department of Defense Gold Star.

27 (d) (1) The Administration, in consultation with the U.S. Department of
28 Defense and appropriate representatives of the various branches of the armed forces,
29 shall adopt regulations specifying those armed forces medals that are of the type
30 described in subsection (a)(2) of this section and which, when awarded to an
31 individual, qualify that individual to apply for special registration under this section.

32 (2) The Administration may adopt other regulations as necessary to
33 govern the issuance of special registration numbers and special registration plates
34 under this section.

1 (e) If, whether by act of the parties or by operation of law, the title or
2 ownership interest in a vehicle assigned a special registration under this section is
3 transferred from the joint names of a husband and wife to the individual name of
4 either spouse, the transferee may continue to use the same special registration plates
5 issued under this section on the vehicle after the transfer.

13 SECTION 14. AND BE IT FURTHER ENACTED, That, subject to Section 13 of
14 this Act, this Act shall take effect July 1, 2005. Section 3 of this Act shall remain
15 effective for a period of 10 years and, at the end of June 30, 2015, with no further
16 action required by the General Assembly, Section 3 of this Act shall be abrogated and
17 of no further force and effect. Section 5 of this Act shall remain effective for a period of
18 2 years and, at the end of June 30, 2007, with no further action required by the
19 General Assembly, Section 5 of this Act shall be abrogated and of no further force and
20 effect.

26 SECTION 2. AND BE IT FURTHER ENACTED, That the Drafter's Notes
27 contained in this Act are not law and may not be considered to have been enacted as
28 part of this Act.

29 SECTION 3. AND BE IT FURTHER ENACTED, That this Act is an emergency
30 measure, is necessary for the immediate preservation of the public health or safety,
31 has been passed by a yea and nay vote supported by three-fifths of all the members
32 elected to each of the two Houses of the General Assembly, and shall take effect from
33 the date it is enacted.
