A BILL ENTITLED

1 AN ACT concerning

2 **State Budget – Modifications – Reporting**

3 FOR the purpose of requiring the State budget books to include a separate section for
4 certain fiscal years, listing certain changes in policy or administration that will
5 reduce, by a certain amount, the level of funding or level of services in any
6 program or program area; requiring the section to include, for a certain fiscal
7 year, a summary of certain changes reducing funding or services below certain
8 levels; defining a certain term; and generally relating to a requirement that the
9 budget books contain a section relating to certain reductions.

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
16 MARYLAND, That the Laws of Maryland read as follows:

17 **Article – State Finance and Procurement**

18 **7–123.**

19 (A) IN THIS SECTION, “QUALIFIED REDUCTION” MEANS A CHANGE IN A
20 POLICY, PRACTICE, OR PROCEDURE WHICH REPRESENTS AT LEAST A \$50,000
21 OR A 5% REDUCTION IN UNITS OF SERVICE OF ANY PROGRAM OR PROGRAM
22 AREA FROM THE PRECEDING FISCAL YEAR THAT:

23 (1) IS ADOPTED OR INTENDED TO BE ADOPTED TO IMPLEMENT
24 THE EXPENDITURE LEVELS SHOWN IN THE BUDGET BOOKS; AND

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.
[Brackets] indicate matter deleted from existing law.

2 **(B) THIS SECTION APPLIES ONLY TO PROGRAMS AND SERVICES**
3 **PROVIDED BY:**

4 **(1) THE DEPARTMENT OF AGING;**

5 **(2) THE DEPARTMENT OF AGRICULTURE;**

6 **(3) THE DEPARTMENT OF BUSINESS AND ECONOMIC**
7 **DEVELOPMENT;**

8 **(4) THE DEPARTMENT OF DISABILITIES;**

9 **(5) THE STATE DEPARTMENT OF EDUCATION;**

10 **(6) THE DEPARTMENT OF HEALTH AND MENTAL HYGIENE;**

11 **(7) THE DEPARTMENT OF HOUSING AND COMMUNITY**
12 **DEVELOPMENT;**

13 **(8) THE MARYLAND INSURANCE ADMINISTRATION;**

14 **(9) THE DEPARTMENT OF HUMAN RESOURCES;**

15 **(10) THE DEPARTMENT OF JUVENILE SERVICES; AND**

16 **(11) THE DEPARTMENT OF NATURAL RESOURCES.**

17 **(C) THE BUDGET BOOKS SHALL INCLUDE A SECTION THAT PROVIDES:**

18 **(1) AN ITEMIZED LIST OF THE AMOUNT OF ANY QUALIFIED**
19 **REDUCTION; AND**

20 **(2) THE DOLLAR AMOUNT OF ANY QUALIFIED REDUCTION**
21 **COMPARED WITH THE ORIGINAL LEGISLATIVE APPROPRIATION FOR THE**
22 **CURRENT YEAR.**

23 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
24 July 1, 2009.
