BY repealing and reenacting, with amendments, Article – State Finance and Procurement Section 14–304 Annotated Code of Maryland (2006 Replacement Volume and 2008 Supplement) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: **Article – State Finance and Procurement** 14–304. (1) The certification agency shall develop and maintain a directory of all certified minority business enterprises.
