CHAPTER _____

1 AN ACT concerning

2 **Worcester County – Gaming – Bingo**

3 FOR the purpose of increasing certain fees for bingo conducted in Worcester County;
4 increasing certain maximum prizes offered in bingo; repealing a prohibition
5 against conducting bingo outside a certain area; specifying that a certain game
6 may be played without a prize limit; repealing a prohibition against conducting
7 bingo on Sunday; authorizing a person to advertise in a certain way the location
8 and time of bingo and bingo prizes; and generally relating to bingo conducted in
9 Worcester County.

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
21 MARYLAND, That the Laws of Maryland read as follows:

22 **Article – Criminal Law**

2 This subtitle applies only in Worcester County.

3 13-2610.

4 (a) An organization or municipal corporation described in § 13-2606 of this
5 subtitle that intends to conduct bingo under this part must obtain:

6 (1) an annual license to conduct bingo for more than 15 days in a year;
7 or

8 (2) a temporary license to conduct bingo for 15 days or fewer in a year.

9 (b) (1) An applicant for a license shall submit to the board an application
10 on the form that the board by regulation requires.

11 (2) The application form shall require:

12 (i) the name of the applicant;

13 (ii) the name of each principal officer of the applicant; and

14 (iii) a certification that no person will conduct bingo except a
15 person who:

16 1. is a salaried employee or bona fide member of the
17 applicant; and

18 2. shall not receive any form of commission or bonus.

19 (c) (1) An applicant shall pay to the board a license fee of:

20 (i) \$100 for an annual license; or

21 (ii) [~~\$3~~] **\$25 IN ADDITION TO \$5** for each day bingo is
22 conducted for a temporary license.

23 (2) The board shall pay to the county commissioners all license fees
24 collected under this part.

25 (d) The board shall issue a license to each applicant who meets the
26 requirements of this part and the regulations adopted under this part.

1 [(e) A license may not be issued to an applicant to conduct bingo outside the
2 election district in which the main office, headquarters, or usual meeting place of the
3 applicant is located.]

4 [(f)] (E) If an applicant conducts bingo on premises that are leased by the
5 applicant, the lease agreement must be approved by the board before a license may be
6 issued.

7 [(g)] (F) The board may deny a license to an applicant or suspend or revoke
8 a license if the applicant or licensee has violated this part or any regulation adopted
9 under this part.

10 13–2611.

11 (a) The charge for admission to a place in order to participate in bingo
12 conducted under this part may not exceed [~~\$1~~] **\$5**.

13 (b) (1) Except as provided in paragraph (2) of this subsection, the value of
14 a prize in money, merchandise, or services for any one game of bingo conducted under
15 this part may not exceed [~~\$50~~] **\$200**.

16 (2) Jackpot prizes may be offered in a maximum amount of [~~\$1,000~~]
17 **\$5,000**.

18 (3) **“WINNER TAKE ALL” GAMES MAY BE OFFERED WITHOUT A**
19 **PRIZE LIMIT.**

20 (c) A licensee’s employees and the terms of their employment must be
21 approved by the board before they may conduct bingo under this part.

22 (d) A minor may not be allowed to participate in bingo conducted under this
23 part.

24 [(e) Bingo may not be conducted under this part on Sunday.]

25 [(f)] (E) Bingo may not be conducted under this part in a room or area
26 where alcoholic beverages are sold or served during the game.

27 [(g)] (F) A licensee under this part may not conduct bingo on more than 125
28 days in a year.

30 [(a) Except as provided in subsection (b) of this section, a] **A** person may [not]
31 advertise the location or time of bingo, or the prizes awarded or to be awarded, by:

- 1 (1) radio, television, or sound systems;
2 (2) billboards, posters, or handbills; or
3 (3) any other means addressed to the public.

4 [(b) (1) Unless otherwise prohibited by county or municipal law, one sign
5 not exceeding 36 square feet, stating that bingo will be conducted, may be displayed on
6 or adjacent to the premises where bingo will be conducted.

7 (2) In accordance with regulations adopted under § 13-2608 of this
8 subtitle, notice that bingo will be conducted may be posted on a bulletin board or
9 included on a poster inside a hotel, motel, restaurant, or store that is located in the
10 election district in which the game will be conducted.]

11 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
12 July 1, 2009.
