## **Health Occupations – Licensure of Social Workers**

FOR the purpose of requiring the State Board of Social Work Examiners to notify applicants for licensure whether the applicants have been approved to take a certain examination within a certain time period; altering certain requirements for a waiver of examination requirements for certain applicants who are licensed or registered to practice social work in other states; and generally relating to the licensure of social workers.
