A BILL ENTITLED

1 AN ACT concerning

2 **Vehicle Laws – Distracted Driving – Prohibition**

3 FOR the purpose of prohibiting a person from driving a motor vehicle in an inattentive
4 manner resulting in the unsafe operation of the motor vehicle, where the
5 inattention is caused by the person engaging in a certain preoccupying activity;
6 providing that a violation of this Act is not a moving violation for the purpose of
7 assessing certain points; authorizing a police officer to enforce this Act only as a
8 secondary offense; defining certain terms; and generally relating to distracted
9 driving.

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
21 MARYLAND, That the Laws of Maryland read as follows:

22 **Article – Transportation**

23 **21–901.3.**

24 (A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE
25 MEANINGS INDICATED.

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.



- 1 **(2) “PREOCCUPYING ACTIVITY” INCLUDES:**
- 2 **(I) READING OR WRITING;**
- 3 **(II) PERFORMING PERSONAL GROOMING;**
- 4 **(III) USING A WIRELESS COMMUNICATIONS DEVICE;**
- 5 **(IV) ADJUSTING CARGO;**
- 6 **(V) EATING, DRINKING, OR SMOKING;**
- 7 **(VI) PHYSICALLY ATTENDING TO ANOTHER PASSENGER;**
- 8 **AND**
- 9 **(VII) OPERATING OR OBSERVING A VIDEO DISPLAY.**

10 **(3) “WIRELESS COMMUNICATION DEVICE” HAS THE MEANING**
11 **STATED IN § 21-1124 OF THIS TITLE.**

12 **(B) A PERSON IS GUILTY OF DISTRACTED DRIVING IF THE PERSON**
13 **DRIVES A MOTOR VEHICLE IN AN INATTENTIVE MANNER RESULTING IN THE**
14 **UNSAFE OPERATION OF THE MOTOR VEHICLE, WHERE THE INATTENTION IS**
15 **CAUSED BY THE PERSON ENGAGING IN A PREOCCUPYING ACTIVITY.**

16 **(C) A VIOLATION OF THIS SECTION IS NOT A MOVING VIOLATION FOR**
17 **THE PURPOSE OF ASSESSING POINTS UNDER § 16-402 OF THIS ARTICLE.**

18 **(D) A POLICE OFFICER MAY ENFORCE THIS SECTION ONLY AS A**
19 **SECONDARY ACTION WHEN THE POLICE OFFICER DETAINS A DRIVER FOR A**
20 **SUSPECTED VIOLATION OF ANOTHER PROVISION OF THE CODE.**

21 27-101.

22 **(a) It is a misdemeanor for any person to violate any of the provisions of the**
23 **Maryland Vehicle Law unless the violation:**

24 **(1) Is declared to be a felony by the Maryland Vehicle Law or by any**
25 **other law of this State; or**

26 **(2) Is punishable by a civil penalty under the applicable provision of**
27 **the Maryland Vehicle Law.**

1 (b) Except as otherwise provided in this section, any person convicted of a
2 misdemeanor for the violation of any of the provisions of the Maryland Vehicle Law is
3 subject to a fine of not more than \$500.

4 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
5 October 1, 2009.
