#### 1 AN ACT concerning

# Maryland Medical Assistance Program – Uniform Statewide Transportation System for Nonemergency Services

- 4 FOR the purpose of requiring the Department of Health and Mental Hygiene to develop and implement a certain uniform statewide transportation system for 5 6 certain Maryland Medical Assistance Program recipients; requiring the 7 transportation system to be operated by a single entity that responds directly to 8 the Department; requiring the Department to select an entity to operate the 9 transportation system through a competitive bid process on or before a certain 10 date; requiring the Department to use funds generated from efficiencies resulting from the creation of the transportation system for certain purposes; 11 and generally relating to transportation for Maryland Medical Assistance 12 Program recipients. 13
