1 AN ACT concerning 2 Pharmacists - Administration of Vaccinations - Expanded Authority 3 FOR the purpose of expanding the authority of pharmacists to administer certain 4 vaccinations to individuals under certain circumstances; altering a certain definition; and generally relating to the expansion of the authority of 5 pharmacists to administer vaccinations to individuals. 6 7 BY repealing and reenacting, with amendments, 8 Article – Health Occupations 9 Section 12-101(s) and 12-508 Annotated Code of Maryland 10 (2005 Replacement Volume and 2008 Supplement) 11 12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 13 MARYLAND, That the Laws of Maryland read as follows: 14 **Article - Health Occupations** 15 12–101. "Practice pharmacy" means to engage in any of the following (1) 16 (\mathbf{s}) 17 activities: 18 (i) Providing pharmaceutical care; 19 Compounding, dispensing, or distributing prescription drugs (ii) 20 or devices; 21Compounding or dispensing nonprescription drugs or (iii) 22 devices;

24 25	(a) (1) A pharmacist may administer an influenza vaccination to an individual, in accordance with regulations adopted under subsection (c) of this section.							
26 27	(2) A pharmacist may administer a vaccination for pneumococcal pneumonia or herpes zoster to an individual if:

29	(ii) The individual has a prescription from a physician;

- 4 (v) The vaccination is administered in accordance with 5 regulations adopted under subsection (c) of this section.
- 6 **(3)** A PHARMACIST MAY ADMINISTER A VACCINATION TO AN 7 INDIVIDUAL, IN ACCORDANCE WITH REGULATIONS **ADOPTED UNDER** 8 SUBSECTION (C) OF THIS SECTION, THAT HAS BEEN DETERMINED BY THE 9 BOARD, WITH THE BOARD OF PHYSICIANS AND THE BOARD OF NURSING, TO BE 10 IN THE BEST HEALTH INTERESTS OF THE COMMUNITY.
- 11 (b) The Board shall set reasonable fees for the administration of vaccinations 12 in accordance with subsection (a) of this section.
- 13 (c) The Board, with the Board of Physicians and the Board of Nursing, shall jointly develop and adopt regulations to provide for patient safety and to implement this section.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2009.
