3 FOR the purpose of requiring the Secretary of Budget and Management to include in 4 the State Employee and Retiree Health and Welfare Benefits Program an option 5 to purchase up to a certain amount of additional life insurance coverage for 6 certain employees; authorizing the Secretary of State Police and the Secretary of 7 Budget and Management to award certain death benefits and funeral expenses to certain recipients on behalf of certain individuals; requiring that certain death 8 benefits and funeral expenses be paid and funded in a certain manner; providing 9 for the application of certain provisions of this Act; providing for the termination 10 11 of certain provisions of this Act; and generally relating to benefit options under the State Employee and Retiree Health and Welfare Benefits Program benefits 12 for public safety employees. 13
