BY repealing and reenacting, with amendments, Article – Economic Development Section 5–1201, 5–1202, 5–1203, and 5–1205 Annotated Code of Maryland (2008 Volume) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: **Article - Economic Development** 5-1201.(a) In this subtitle the following words have the meanings indicated. "Fund" means the Maryland Not-For-Profit Development Center Program Fund established under § 5–1204 of this subtitle.
