A BILL ENTITLED

1 AN ACT concerning

Family Law - State Citizens Review Board for Children and Local Boards of Review - Duties

4 FOR the purpose of altering the cases required to be reviewed by the State Citizens Review Board for Children and local boards of review for children in 5 6 out-of-home care; requiring the State Board to tabulate certain results and 7 submit them to the Department of Human Resources; altering the requirements 8 for certain community forums; altering the frequency of certain case reviews by 9 local boards; altering the findings and recommendations required to be included 10 in certain reports; repealing a requirement that a local board explain a certain finding; repealing a provision authorizing certain case reviews to include certain 11 questions; and generally relating to the State Citizens Review Board for 12 Children and local boards of review. 13

- 20 WHEREAS, The State has taken measures to ensure the safety and 21 permanency of children entrusted in its care; and
- 22 WHEREAS, Local boards should focus on the permanency of children; and

WHEREAS, It is necessary to realign the duties of the local citizens review boards for children to avoid duplication of case review and to ensure that the system is working together; and
