## Economic Development - Maryland Stem Cell Research Act - Revisions

3 FOR the purpose of altering the name of the Stem Cell Research Commission to be the 4 Stem Cell and Biotechnologies Commission; requiring the Commission to 5 establish certain procedures and guidelines regarding research supporting a 6 qualified technology; altering the name of the Maryland Stem Cell Research 7 Fund to be the Maryland Stem Cell and Biotechnologies Research Fund; 8 altering the purpose of the Fund; altering the approved uses of money in the 9 Fund; requiring that a certain percentage of awards per year be made to certain 10 for-profit companies; requiring that priority be given to certain applicants when 11 awarding funds to applicants in the nonprofit sector; altering the membership of the Maryland Stem Cell Research Commission; altering the composition of the 12 membership of the peer review committee; requiring the peer review committee 13 14 to consider certain factors when reviewing a proposal; repealing the provision of law prohibiting a member of the peer review committee from residing in the 15 16 State; and altering the requirements for a certain report; altering the definition 17 of certain terms; defining a certain term; and generally relating to the Maryland Stem Cell Research Act. 18
