A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2006 - Montgomery County -**
3 **Our House Youth Home**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2006
5 to extend the deadline by which the Board of Directors of Our House Youth
6 Home, Inc. may present evidence to the Board of Public Works that a matching
7 fund will be provided.

8 BY repealing and reenacting, with amendments,
9 Chapter 46 of the Acts of the General Assembly of 2006, as amended by Chapter
10 219 of the Acts of the General Assembly of 2008
11 Section 1(3) Item ZA01(CP) and ZA02(AZ)

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
13 MARYLAND, That the Laws of Maryland read as follows:

14 **Chapter 46 of the Acts of 2006, as amended by Chapter 219 of the Acts of 2008**

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
16 MARYLAND, That:

18 (CP) Our House Youth Home. Provide a grant equal to the lesser of
19 (i) \$175,000 or (ii) the amount of the matching fund provided,
20 to the Board of Directors of Our House Youth Home, Inc. for
21 the construction and capital equipping of a new dormitory at
22 Our House Youth Home, located in Olney, subject to a
23 requirement that the grantee grant and convey a historic
24 easement to the Maryland Historical Trust. Notwithstanding
25 Section 1(5) of this Act, the grantee has until June 1, [2009]
