FISCAL AND POLICY NOTE

House Bill 930
Appropriations

(Delegate Hubbard, *et al.*)

Creation of a State Debt - Prince George's County - Bowie Police Dispatch Center

The bills listed below authorize the issuance of general obligation bonds to provide grants to various recipients for the acquisition, planning, design, construction, expansion, repair, restoration, renovation, reconstruction, or capital equipping of various facilities.

Most bills require either a hard or soft match as noted. Where no match is required the term “grant” is indicated. A hard match means the recipient provides a dollar-for-dollar match of the State funds and does not expend the matching funds until after the effective date of the authorizing act. A soft match is any other type of match. Soft matches include the use of the value of the real property as the match, in-kind contributions such as materials or construction services, or funds expended prior to the effective date of the bill. A match key is provided immediately below the list of projects.

The list is organized into two categories: statewide bond bills and local bond bills. Within the local bond bill category the projects are sorted first by the county in which the project is located and then alphabetically by project title. Most projects have both a House and a Senate bill.

As introduced by the Governor, the Maryland Consolidated Capital Bond Loan (MCCBL) of 2009, referred to as the capital budget, earmarks \$15 million for legislative initiatives. However, because the General Assembly can both reduce and add to the capital budget, the budget committees may consider bond bill requests during the 2009 session in excess of the amount earmarked in MCCBL as introduced by the Governor.

Fiscal Summary

State Effect: These grants will be part of the total general obligation debt authorization for FY 2010. The Spending Affordability Committee (SAC) recommended a general obligation debt authorization of \$1.1 billion for FY 2010, of which \$5 million is authorized under separate legislation (Chapter 103 of 2001 as amended by Chapter 46 of 2006) for the Tobacco Transition Program. The Governor's budget as introduced assumes general obligation debt authorizations totaling \$1.2 billion, including \$5 million for the Tobacco Transition Program and \$33 million preauthorized for FY 2010 in the 2008 session capital budget bill (Chapter 336 of 2008). The additional \$11.1 million over the SAC recommendation will come from the de-authorization of prior year authorizations. State debt service costs on \$1.1 billion will total a maximum of \$118.2 million annually based on an interest rate of 5%. The State last sold bonds in March 2009, and those bonds bear the single coupon rate of 5% over 15 years.

Local Effect: None, unless the recipient is a local government.

Small Business Effect: Minimal.
