### AMENDMENT NO. 1

On page 1, in line 14, after "crime" insert "or act"; and in lines 15, 17, and 19, in each instance, after "court" insert "or juvenile court".

On page 2, strike beginning with "requiring" in line 3 down through "petitions;" in line 4.

### AMENDMENT NO. 2

On page 9, strike beginning with "FOR" in line 22 down through the first "OF" in line 23 and substitute "INVOLVING"; in line 23, strike "AND" and substitute:

"(5) A PERSON WHO IS REQUIRED TO REGISTER UNDER § 11-704(C) OF THIS SUBTITLE; AND";

in line 24, strike "(5)" and substitute "(6)"; in line 32, strike "The" and substitute "(1) EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS SUBSECTION, THE"; and in line 34, strike "August 1, 2006" and substitute "OCTOBER 1, 2010".

On page 10, in lines 1 and 2, strike "(1)" and "(2)", respectively, and substitute "(1)" and "(11)", respectively; after line 3, insert:

"(2) FOR A PERSON WHO IS REQUIRED TO REGISTER UNDER § 11-704(C) OF THIS SUBTITLE, THE TERM OF LIFETIME SEXUAL OFFENDER SUPERVISION IMPOSED FOR AN ACT COMMITTED ON OR AFTER OCTOBER 1, 2010, SHALL:

- (I) <u>COMMENCE WHEN THE PERSON'S OBLIGATION TO</u>
  REGISTER COMMENCES; AND
- (II) EXPIRE WHEN THE PERSON'S OBLIGATION TO REGISTER EXPIRES, UNLESS THE JUVENILE COURT:
- 1. <u>FINDS AFTER A HEARING THAT THERE IS A</u>
  COMPELLING REASON FOR THE SUPERVISION TO CONTINUE; AND
- 2. ORDERS THE SUPERVISION TO CONTINUE FOR A SPECIFIED PERIOD OF TIME.";

in line 5, after "COURT" insert ", OR JUVENILE COURT IN THE CASE OF A PERSON WHO IS REQUIRED TO REGISTER UNDER § 11-704(C) OF THIS SUBTITLE,"; in line 7, after "SENTENCING" insert ", OR IMPOSITION OF THE REGISTRATION REQUIREMENT IN JUVENILE COURT,"; in line 10, after "COURT" insert "OR JUVENILE COURT"; and in line 27, strike "CERTIFIED".

On page 11, in lines 9 and 10, in each instance, after "COURT" insert "OR JUVENILE COURT".

On page 12, in line 30, strike "(G)" and substitute "(F)".

On page 13, strike beginning with "ON" in line 1 down through "(2)" in line 9; in line 11, strike "THE" and substitute "A"; in the same line, after "CHARGE" insert "OF VIOLATION OF A CONDITION OF LIFETIME SEXUAL OFFENDER SUPERVISION"; in line 12, strike "(3)" and substitute "(2)"; in the same line, strike "AT THE HEARING"; in line 13, strike "VIOLATED" and substitute "COMMITTED A VIOLATION OF"; strike
