- (I) THE NEED TO INDICATE IN THE CHECK-OFF BOX DESCRIBED IN SUBSECTION (C)(1)(III) OF THIS SECTION THAT THE PERSON IS REQUESTING A TRIAL DATE; AND
- (II) THE CONSEQUENCES OF FAILING TO INDICATE IN THE CHECK-OFF BOX THAT THE PERSON IS REQUESTING A TRIAL.
- (2) IF A PERSON INDICATES IN THE CHECK-OFF BOX DESCRIBED IN SUBSECTION (C)(1)(III) OF THIS SECTION THAT THE PERSON IS REQUESTING A TRIAL DATE, THE DISTRICT COURT SHALL SCHEDULE A TRIAL DATE.
- (3) IF A PERSON DOES NOT INDICATE IN THE CHECK-OFF BOX DESCRIBED IN SUBSECTION (C)(1)(III) OF THIS SECTION THAT THE PERSON IS REQUESTING A TRIAL DATE, THE DISTRICT COURT MAY NOT SCHEDULE A TRIAL
