AMENDMENTS TO SENATE BILL 590
(Third Reading File Bill)

AMENDMENT NO. 1

On page 8, in line 1, strike “CLEARLY”.

On page 15, in line 27, strike “CLEARLY”.

AMENDMENT NO. 2

On page 8, in line 34, after “ORGANIZATION” insert “, WHICH MAY NOT INCLUDE ITEMS OR TOPICS NOT PREVIOUSLY RAISED IN THE BARGAINING PROCESS”.

On page 16, in line 22, after “ORGANIZATION” insert “, WHICH MAY NOT INCLUDE ITEMS OR TOPICS NOT PREVIOUSLY RAISED IN THE BARGAINING PROCESS”.

AMENDMENT NO. 3

On page 9, in line 24, strike “OR”; after line 24, insert:

“(II) ACCEPT THE WRITTEN PROPOSED SETTLEMENT IN PART, AS MUTUALLY AGREED ON BY THE PUBLIC SCHOOL EMPLOYER AND THE EMPLOYEE ORGANIZATION; OR”;

and in line 25, strike “(II)” and substitute “(III)”.

On page 17, in line 15, strike “OR”; after line 15, insert:

(Over)

“(II) ACCEPT THE WRITTEN PROPOSED SETTLEMENT IN PART, AS MUTUALLY AGREED ON BY THE PUBLIC SCHOOL EMPLOYER AND THE EMPLOYEE ORGANIZATION; OR”;

and in line 16, strike “(II)” and substitute “(III)”.

AMENDMENT NO. 4

On page 10, in line 16, after the semicolon insert “AND”; strike beginning with “**DECIDE**” in line 17 down through “(VII)” in line 19; in line 19, after “**RECEIVE**” insert “, HEAR,”; and in line 20, after the comma insert “WHETHER OR NOT OFFERED THROUGH AN ATTORNEY,”.

On page 18, in line 7, after the semicolon insert “AND”; strike beginning with “**DECIDE**” in line 8 down through “(VII)” in line 10; in line 10, after “**RECEIVE**” insert “, HEAR,”; and in line 11, after the comma insert “WHETHER OR NOT OFFERED THROUGH AN ATTORNEY,”.

AMENDMENT NO. 5

On page 10, in lines 26 and 27, strike “**FROM THE COUNTY’S GENERAL FUND**” and substitute “, CONSIDERING THEIR EXISTING RESOURCES,”.

On page 18, in lines 17 and 18, strike “**FROM THE COUNTY’S GENERAL FUND**” and substitute “, CONSIDERING THEIR EXISTING RESOURCES,”.

AMENDMENT NO. 6

On page 20, in lines 16 and 17, strike “**OF THE EDUCATION OR BUSINESS COMMUNITY,**”.
