On page 1, in line 2, strike "Health" and substitute "<u>Business Regulation –</u> <u>Lodging Establishments</u>"; in the same line, strike " – Posting of"; strike beginning with "requiring" in line 4 down through "hotline;" in line 6 and substitute "<u>requiring the</u> <u>Department of Labor, Licensing, and Regulation to design a sign that contains certain</u> <u>information regarding the National Human Trafficking Resource Center Hotline;</u> <u>requiring the sign to meet certain requirements and be placed on the Department's</u> <u>website; requiring a lodging establishment to post a certain sign in certain places for a</u> <u>certain period of time if certain conditions are met; providing a certain penalty for the</u> <u>violation of a certain provision of this Act;</u>"; in line 7, strike "the posting of" and substitute "<u>lodging establishments and</u>"; in line 8, strike "hotline" and substitute "<u>Hotline</u>"; strike in their entirety lines 9 through 13, inclusive; and after line 13, insert:

"<u>BY adding to</u>

<u>Article – Business Regulation</u> <u>Section 15-207</u> <u>Annotated Code of Maryland</u> (2004 Replacement Volume and 2009 Supplement)".

On pages 1 and 2, strike in their entirety the lines beginning with line 16 on page 1 through line 7 on page 2, inclusive.

On page 2, after line 7, insert:

- (2) <u>THE SIGN SHALL:</u>
 - (I) <u>BE AT LEAST 3 BY 5 INCHES IN SIZE;</u>

(II) <u>CONTAIN THE TEXT REQUIRED UNDER PARAGRAPH (1)</u> OF THIS SUBSECTION IN ENGLISH, SPANISH, AND ANY OTHER LANGUAGES REQUIRED BY THE FEDERAL VOTING RIGHTS ACT; SB0542/317570/1 Amendments to SB 542 Page 3 of 3

(III) DRAW ATTENTION TO THE PHONE NUMBER OF THE NATIONAL HUMAN TRAFFICKING RESOURCE CENTER HOTLINE BY SHOWING THE PHONE NUMBER IN BOLD TYPE; AND

(IV) BE PLACED ON THE DEPARTMENT WEBSITE.

(B) (1) <u>A STATE, COUNTY, OR MUNICIPAL LAW ENFORCEMENT</u> AGENCY MAY ISSUE A CIVIL CITATION TO A LODGING ESTABLISHMENT REQUIRING IT TO POST PROMINENTLY IN EACH GUEST ROOM FOR 1 YEAR THE SIGN THAT IS IDENTICAL TO THE NOTICE REQUIRED TO BE PLACED ON THE WEBSITE OF THE DEPARTMENT UNDER SUBSECTION (A) OF THIS SECTION, IF THE LODGING ESTABLISHMENT IS LOCATED ON PROPERTY WHERE ARRESTS LEADING TO CONVICTIONS OF PROSTITUTION, SOLICITATION OF A MINOR, OR HUMAN TRAFFICKING UNDER TITLE 11, SUBTITLE 13 OF THE CRIMINAL LAW ARTICLE HAVE OCCURRED.

(2) <u>A STATE, COUNTY, OR MUNICIPAL LAW ENFORCEMENT</u> <u>AGENCY SHALL CONSIDER ANY ASSISTANCE IT RECEIVES FROM A LODGING</u> <u>ESTABLISHMENT IN AN INVESTIGATION LEADING TO A CONVICTION UNDER</u> <u>PARAGRAPH (1) OF THIS SUBSECTION IN DETERMINING WHETHER TO ISSUE A</u> <u>CITATION UNDER THIS SUBSECTION.</u>

(C) (1) THE OWNER OF A LODGING ESTABLISHMENT THAT VIOLATES SUBSECTION (B)(1) OF THIS SECTION IS SUBJECT TO A CIVIL PENALTY NOT EXCEEDING \$1,000.

(2) EACH GUEST ROOM THAT DOES NOT HAVE A SIGN IS NOT A SEPARATE VIOLATION.".
