On page 1, in the sponsor line, strike "and Walker" and substitute "<u>Walker, and</u> <u>Conaway</u>"; in line 15, after "circumstances;" insert "<u>clarifying that the imposition or</u> <u>adjustment of special conditions of lifetime sexual offender supervision is a subsequent</u> <u>proceeding under a certain provision of law</u>;"; strike beginning with "requiring" in line 18 down through "petitions;" in line 19; in line 19, strike "authorizing" and substitute "<u>prohibiting</u>"; in the same line, strike "to deny" and substitute "<u>from denying</u>"; and on page 2, in line 1, after "circumstances;" insert "<u>clarifying that certain proceedings are</u> <u>a subsequent proceeding under a certain provision of law</u>;".

AMENDMENT NO. 2

On page 8, in line 9, strike "AND" and substitute:

"(5) <u>A PERSON WHO IS REQUIRED TO REGISTER UNDER § 11-</u> 704(C) OF THIS ARTICLE; AND";
