AMENDMENTS TO HOUSE BILL 473, AS AMENDED
(Third Reading File Bill)

AMENDMENT NO. 1

On page 1 of the bill, in line 10, after “crime” insert “or act”; and in lines 11, 13, and 14, in each instance, after “court” insert “or juvenile court”.

On page 1 of the Judicial Proceedings Committee Amendments (HB0473/848976/1), in Amendment No. 1, strike beginning with “requiring” in line 9 down through “petitions;” in line 10.

AMENDMENT NO. 2

On page 8 of the bill, strike beginning with “**FOR**” in line 13 down through the first “**OF**” in line 14 and substitute “INVOLVING”; after line 14, insert:

“(5) A PERSON WHO IS REQUIRED TO REGISTER UNDER § 11-704(C) OF THIS SUBTITLE; AND”;

in line 21, strike “The” and substitute “**(1) EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS SUBSECTION, THE**”; in line 23, strike “August 1, 2006” and substitute “**OCTOBER 1, 2010**”; in lines 24 and 25, strike “(1)” and “(2)”, respectively, and substitute “**(I)**” and “**(II)**”, respectively; after line 26, insert:

“(2) FOR A PERSON WHO IS REQUIRED TO REGISTER UNDER § 11-704(C) OF THIS SUBTITLE, THE TERM OF LIFETIME SEXUAL OFFENDER SUPERVISION IMPOSED FOR AN ACT COMMITTED ON OR AFTER OCTOBER 1, 2010, SHALL:

(I) COMMENCE WHEN THE PERSON’S OBLIGATION TO REGISTER COMMENCES; AND

(Over)

(II) EXPIRE WHEN THE PERSON’S OBLIGATION TO REGISTER EXPIRES, UNLESS THE JUVENILE COURT:

1. FINDS AFTER A HEARING THAT THERE IS A COMPELLING REASON FOR THE SUPERVISION TO CONTINUE; AND

2. ORDERS THE SUPERVISION TO CONTINUE FOR A SPECIFIED PERIOD OF TIME.”;

in line 27, after “COURT” insert “**, OR JUVENILE COURT IN THE CASE OF A PERSON WHO IS REQUIRED TO REGISTER UNDER § 11-704(C) OF THIS SUBTITLE,**”; in line 29, after “SENTENCING” insert “**, OR IMPOSITION OF THE REGISTRATION REQUIREMENT IN JUVENILE COURT,**”; and in line 32, after “COURT” insert “**OR JUVENILE COURT**”.

On page 9 of the bill, in line 12, strike “CERTIFIED”; and in lines 24 and 25, in each instance, after “COURT” insert “**OR JUVENILE COURT**”.

On page 3 of the Judicial Proceedings Committee Amendments, in line 2 of Amendment No. 3, strike “**AND**”; and in line 3, strike “**(5)**” and substitute “**(6)**”.

AMENDMENT NO. 3

On page 11 of the bill, in line 14, strike “**(G)**” and substitute “**(F)**”.

On page 4 of the Judicial Proceedings Committee Amendments, in Amendment No. 3, strike beginning with “**ON**” in line 12 down through “**CHARGE;**” in line 19.

On page 5 of the Judicial Proceedings Committee Amendments, in Amendment No. 3, in line 1, strike “**(2)**”; in line 3, strike “**THE**” and substitute “**A**”; in line 4, strike

“(3)” and substitute “(2)”; in lines 4 and 5, strike “AT THE HEARING”; and in line 6, strike “VIOLATED” and substitute “COMMITTED A VIOLATION OF”.

On page 11 of the bill, in line 27, after “CHARGE” insert “OF VIOLATION OF A CONDITION OF LIFETIME SEXUAL OFFENDER SUPERVISION”.

On page 12 of the bill, in line 26, strike “SELF OR”; and strike lines 32 and 33 in their entirety.

On page 14 of the bill, in line 4, after “COURT” insert “, OR JUVENILE COURT IN THE CASE OF A PERSON WHO IS REQUIRED TO REGISTER UNDER § 11-704(C) OF THIS SUBTITLE,”.
