<u>AMENDMENTS TO HOUSE BILL 1334</u> (First Reading File Bill)

<u>AMENDMENT NO. 1</u>

On page 1, strike line 2 in its entirety and substitute "<u>Nonpublic Schools –</u> <u>Bullying, Harassment, and Intimidation – Policies</u>"; strike beginning with "providing" in line 3 down through "schools" in line 8 and substitute "requiring nonpublic schools that accept State funds to adopt a policy prohibiting bullying, harassment, and intimidation by a certain date; requiring the policy to include certain provisions; encouraging a nonpublic school to develop the policy in consultation with certain groups; encouraging a nonpublic school to publicize the policy in a certain manner; encouraging a nonpublic school to develop certain educational programs in its efforts to prevent bullying, harassment, and intimidation; providing that certain nonpublic school employees who report acts of bullying, harassment, or intimidation are not civilly liable under certain circumstances; providing that this Act may not be construed to limit the legal rights of a victim of bullying, harassment, or intimidation; defining certain terms; and generally relating to policies prohibiting bullying, harassment, and intimidation in nonpublic schools that accept State funds"; strike line 9 in its entirety; after line 9, insert "BY adding to"; and in line 11, strike "7-424.1" and substitute "<u>7-424.2</u>".

AMENDMENT NO. 2

On page 1, after line 13, insert:

"<u>Preamble</u>

<u>WHEREAS</u>, The National Institutes of Health reports that bullying affects more than 5 million students in grades 6 through 11; and

<u>WHEREAS</u>, According to the United States Department of Health and Human Services, bullies identified by age 8 are six times more likely to have criminal convictions by age 24; and

<u>WHEREAS</u>, The increased use of the Internet by students is presenting new challenges regarding bullying in schools; and

WHEREAS, Bullying may lead to an increase in absenteeism or the dropout rate; and

<u>WHEREAS</u>, <u>Maintaining a safe environment in schools is integral to promoting</u> <u>learning and success in students</u>; now, therefore,";

and strike in their entirety the lines beginning with line 17 on page 1 through line 17 on page 4, inclusive, and substitute:

"<u>7-424.2.</u>

(A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS INDICATED.

(2) <u>"Bullying, HARASSMENT, AND INTIMIDATION" MEANS ANY</u> INTENTIONAL WRITTEN, VERBAL, OR PHYSICAL ACT, INCLUDING AN ELECTRONIC COMMUNICATION, THAT:

- (I) <u>1.</u> <u>PHYSICALLY HARMS AN INDIVIDUAL;</u>
 - 2. DAMAGES AN INDIVIDUAL'S PROPERTY;

4. PLACES AN INDIVIDUAL IN REASONABLE FEAR OF HARM TO THE INDIVIDUAL'S PERSON OR PROPERTY; AND

(II) <u>1.</u> OCCURS ON SCHOOL PROPERTY, AT A SCHOOL ACTIVITY OR EVENT, OR ON A SCHOOL BUS; OR

2. <u>Substantially disrupts the orderly</u> <u>Operation of a school.</u>

(3) <u>"Electronic communication" means a communication</u> <u>TRANSMITTED BY MEANS OF AN ELECTRONIC DEVICE, INCLUDING A</u> <u>TELEPHONE, CELLULAR PHONE, COMPUTER, OR PAGER.</u>

(B) BY MARCH 31, 2011, EACH NONPUBLIC SCHOOL THAT ACCEPTS STATE FUNDS SHALL ADOPT A POLICY PROHIBITING BULLYING, HARASSMENT, AND INTIMIDATION.

(C) THE POLICY ADOPTED UNDER SUBSECTION (B) OF THIS SECTION SHALL INCLUDE:

(1) <u>A STATEMENT PROHIBITING BULLYING, HARASSMENT, AND</u> INTIMIDATION IN THE SCHOOL;

(3) <u>A DEFINITION OF BULLYING, HARASSMENT, AND</u> <u>INTIMIDATION THAT IS EITHER THE SAME AS SET FORTH IN SUBSECTION (A) OF</u> <u>THIS SECTION OR A DEFINITION THAT IS NOT LESS INCLUSIVE THAN THAT</u> <u>DEFINITION;</u>

(4) STANDARD CONSEQUENCES AND REMEDIAL ACTIONS FOR PERSONS COMMITTING ACTS OF BULLYING, HARASSMENT, OR INTIMIDATION AND FOR PERSONS ENGAGED IN REPRISAL OR RETALIATION, INCLUDING:

(I) <u>SPECIFIC PENALTIES FOR PERSONS WHO REPEATEDLY</u> <u>COMMIT ACTS OF BULLYING, HARASSMENT, OR INTIMIDATION; AND</u>

(II) <u>A REQUIREMENT THAT PERSONS WHO COMMIT ACTS OF</u> <u>BULLYING, HARASSMENT, OR INTIMIDATION RECEIVE EDUCATIONAL AND</u> <u>THERAPEUTIC SERVICES CONCERNING BULLYING PREVENTION;</u>

(5) STANDARD CONSEQUENCES AND REMEDIAL ACTIONS FOR PERSONS FOUND TO HAVE MADE FALSE ACCUSATIONS;

(6) STANDARD PROCEDURES FOR REPORTING ACTS OF BULLYING, HARASSMENT, OR INTIMIDATION, INCLUDING A CHAIN OF COMMAND IN THE REPORTING PROCESS;

(7) STANDARD PROCEDURES FOR THE PROMPT INVESTIGATION OF ACTS OF BULLYING, HARASSMENT, OR INTIMIDATION;

(8) STANDARD PROCEDURES FOR PROTECTING VICTIMS OF BULLYING, HARASSMENT, OR INTIMIDATION FROM ADDITIONAL ACTS OF BULLYING, HARASSMENT, OR INTIMIDATION, AND FROM RETALIATION; AND HB1334/705265/1 Amendments to HB 1334 Page 5 of 6

(9) INFORMATION ABOUT THE TYPES OF SUPPORT SERVICES AVAILABLE TO A STUDENT BULLY OR VICTIM AND ANY BYSTANDERS.

- (4) STUDENTS.

(E) <u>A NONPUBLIC SCHOOL SUBJECT TO THIS SECTION IS ENCOURAGED</u> <u>TO PUBLICIZE THE POLICY ADOPTED UNDER SUBSECTION (B) OF THIS SECTION</u> <u>IN STUDENT HANDBOOKS, ON THE SCHOOL'S WEBSITE, AND ANY OTHER</u> <u>LOCATION OR VENUE THE SCHOOL DETERMINES IS NECESSARY OR</u> <u>APPROPRIATE.</u>

(F) <u>A NONPUBLIC SCHOOL SUBJECT TO THIS SECTION IS ENCOURAGED</u> <u>TO DEVELOP THE FOLLOWING EDUCATIONAL PROGRAMS IN ITS EFFORTS TO</u> PREVENT BULLYING, HARASSMENT, AND INTIMIDATION:

(1) <u>AN EDUCATIONAL BULLYING, HARASSMENT, AND</u> <u>INTIMIDATION PREVENTION PROGRAM FOR STUDENTS, STAFF, VOLUNTEERS,</u> <u>AND PARENTS; AND</u>

(H) <u>The provisions of this section may not be construed to</u> <u>LIMIT THE LEGAL RIGHTS OF A VICTIM OF BULLYING, HARASSMENT, OR</u> <u>INTIMIDATION.</u>".
