On page 1, in the sponsor line, strike "and Jacobs" and substitute "<u>, Jacobs</u>, <u>Forehand, Mooney, and Simonaire</u>"; in line 5, after "ongoing" insert "<u>, to repeal the</u> <u>requirement that members have the commission of certain crimes as a primary</u> <u>objective or activity, and to clarify that a criminal gang may include certain otherwise</u> <u>lawful entities or associations</u>"; strike beginning with "defining" in line 6 down through "purposes;" in line 7; and strike beginning with "prohibiting" in line 10 down through "gang;" in line 11.

AMENDMENT NO. 2

On page 2, strike beginning with the first "or" in line 3 down through "members" in line 4 and substitute "<u>OR ASSOCIATION OF THREE OR MORE</u> <u>PERSONS, INCLUDING OTHERWISE LAWFUL ENTITIES OR ASSOCIATIONS,</u> <u>WHETHER PUBLIC OR PRIVATE, SECULAR OR RELIGIOUS, OR INCORPORATED OR</u> <u>UNINCORPORATED, WHOSE MEMBERS</u>"; in line 10, strike "primary"; and in line 18, after "INITIATION" insert "<u>HAZING, OR ADMISSIONS</u>".

AMENDMENT NO. 3

On page 3, in line 28, strike "or"; and in line 30, after "Article" insert "<u>; OR</u>

(5) <u>A FELONY VIOLATION OF TITLE 8 OF THIS ARTICLE</u>".

AMENDMENT NO. 4

On page 2, in line 15, strike "OVERT OR COVERT"; strike beginning with "A" in line 17 down through "(IV)" in line 18; in line 18, after "RITUAL" insert "<u>THAT IS</u> <u>ITSELF A CRIMINAL OFFENSE</u>"; in line 19, strike "(V)" and substitute "<u>(IV)</u>"; and in the same line, strike "METHOD OF OPERATION OR".
