On page 1, in line 4, after "requiring" insert "<u>the Board of Trustees of the State</u> <u>Retirement and Pension System to reduce the retirement allowance of certain retirees</u> <u>by a certain amount beginning on a certain date and continuing the reduction until</u> <u>the retirement allowance equals a certain amount; requiring</u>"; and in line 22, strike "29–402" and substitute "<u>21–113(c)</u>".

On page 2, in line 3, strike "§ 29–402 OF THIS ARTICLE" and substitute "<u>SUBSECTION (C) OF THIS SECTION</u>"; strike in its entirety line 11; in line 12, strike "(A)" and substitute "<u>(C) (1)</u>"; in lines 14, 16, and 18, strike "(1)", "(2)", and "(3)", respectively, and substitute "<u>(I)</u>", "<u>(II)</u>", and "<u>(III)</u>", respectively; in line 17, strike "AND"; and in line 20, after "EMPLOYEE" insert "; AND

## (IV) ON JULY 1, 2010, IS RECEIVING A RETIREMENT ALLOWANCE THAT IS GREATER THAN THE RETIREMENT ALLOWANCE THAT THE RETIREE IS ENTITLED TO RECEIVE".

#### AMENDMENT NO. 3

On pages 2 and 3, strike in their entirety the lines beginning with line 21 on page 2 through line 22 on page 3, inclusive, and substitute:

(3) (I) BEGINNING JULY 1, 2010, AND EACH SUBSEQUENT JULY 1, THE BOARD OF TRUSTEES SHALL SUSPEND ANY ANNUAL RETIREMENT ALLOWANCE ADJUSTMENT THE RETIREE IS ENTITLED TO RECEIVE UNDER TITLE 29, SUBTITLE 4 OF THIS ARTICLE UNTIL THE RETIREMENT ALLOWANCE THE RETIREE IS RECEIVING EQUALS THE AMOUNT THE RETIREE IS ENTITLED TO RECEIVE AS OF JUNE 30, 2010.

(II) BEGINNING ON THE JULY 1 IMMEDIATELY FOLLOWING THE LAST REDUCTION MADE TO A RETIREE'S MONTHLY RETIREMENT ALLOWANCE BY THE BOARD OF TRUSTEES UNDER PARAGRAPH (2) OF THIS SUBSECTION, THE BOARD OF TRUSTEES SHALL:

1. <u>REINSTATE THE APPLICATION OF ANY ANNUAL</u> <u>RETIREMENT ALLOWANCE ADJUSTMENT THAT THE RETIREE IS ENTITLED TO</u> RECEIVE UNDER TITLE 29, SUBTITLE 4 OF THIS ARTICLE; AND

2. ADJUST THE RETIREE'S ALLOWANCE TO INCLUDE ANY ACCUMULATED COST-OF-LIVING ADJUSTMENTS FROM THE DATE THE COST-OF-LIVING ADJUSTMENTS WERE SUSPENDED UNDER SUBPARAGRAPH (I) OF THIS PARAGRAPH.";
