On page 2, in line 7, strike "SERVICE-DISABLED VETERAN" and substitute "<u>VETERAN-OWNED SMALL</u>"; in line 10, strike "(A)"; and strike beginning with the first "THE" in line 10 down through "AND" in line 30 and substitute "<u>, "VETERAN-OWNED SMALL BUSINESS ENTERPRISE" MEANS A BUSINESS THAT IS VERIFIED BY THE CENTER FOR VETERANS ENTERPRISE OF THE UNITED STATES DEPARTMENT OF VETERANS AFFAIRS AS A VETERAN-OWNED SMALL <u>BUSINESS.</u>".</u>

AMENDMENT NO. 3

On page 3, strike in their entirety lines 1 through 10, inclusive; in line 12, strike "JANUARY 1, 2011," and substitute "JULY 1, 2012,"; in lines 16 and 23, in each instance, strike "CERTIFIED SERVICE-DISABLED"; in line 19, strike "SERVICE-DISABLED"; and in lines 16, 19, and 24, in each instance, strike "VETERAN" and substitute "<u>VETERAN-OWNED SMALL</u>".
