AMENDMENTS TO SENATE BILL 129
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in the sponsor line, strike “and Kramer” and substitute “Kramer, Middleton, Astle, Exum, Garagiola, and Klausmeier”; in line 7, strike “request” and substitute “conduct a”; strike beginning with “checks” in line 7 down through “fees” in line 10 and substitute “check”; in line 14, after “information;” insert “authorizing an international marriage broker to disclose certain information only after obtaining certain written consent;”; in line 17, after “penalty;” insert “requiring the Department of Labor, Licensing, and Regulation, in consultation with the Department of Public Safety and Correctional Services, to report on and make certain recommendations relating to registering and licensing international marriage brokers;”; and in line 21, strike “19-606” and substitute “19-607”.

AMENDMENT NO. 2

On page 2, strike in their entirety lines 8 through 11; in lines 12, 15, and 18, strike “(D)”, “(E)”, and “(F)”, respectively, and substitute “(C)”, “(D)”, and “(E)”, respectively; in line 17, strike “**THAT IS OBTAINED FROM THE CENTRAL REPOSITORY**”; in line 27, strike “**A COUNTRY OTHER THAN THE UNITED STATES**” and substitute “**PERSON**”; and strike beginning with “OF” in line 29 down through “**NATURE**” in line 30.

On page 3, in line 15, after “(A)” insert “**(1)**”; in line 17, after “BASIC” insert “**HUMAN**”; after line 18, insert:

“(2) THE HUMAN RIGHTS INFORMATION PROVIDED UNDER PARAGRAPH (1) OF THIS SUBSECTION MAY BE PREPARED BY AN ORGANIZATION THAT IS NOT AFFILIATED WITH THE INTERNATIONAL MARRIAGE BROKER.”;

(Over)

and in line 30, strike “A” and substitute “IN ACCORDANCE WITH FEDERAL LAW, A”.

On page 4, strike beginning with “THAT” in line 2 down through “SUBTITLE” in line 3; in line 3, strike “AND”; in line 5, after “BROKER” insert “;

(3) PROVIDE THE CLIENT’S OWN STATE AND FEDERAL CRIMINAL HISTORY TO THE INTERNATIONAL MARRIAGE BROKER; AND

(4) NOTIFY THE INTERNATIONAL MARRIAGE BROKER IF THE CLIENT HAS PREVIOUSLY SPONSORED AN INTERNATIONAL SPOUSE”;

in line 15, strike “REQUESTED CRIMINAL HISTORY RECORD”; in line 16, strike “IN ACCORDANCE WITH” and substitute “FROM THE CRIMINAL HISTORY RECORDS CHECK REQUIRED UNDER”; in line 24, strike “(A) THE” and substitute “AT THE TIME AN INTERNATIONAL MARRIAGE BROKER CONTRACTS FOR SERVICES WITH A CLIENT, THE”; strike beginning with “REQUEST” in line 24 down through “CLIENT” in line 25 and substitute “CONDUCT A”; strike beginning with “CHECKS” in line 26 down through “REPOSITORY” in line 27 and substitute “CHECK OF THE CLIENT, INCLUDING A SEARCH OF THE SEX OFFENDER REGISTRY”; and strike in their entirety lines 28 through 33, inclusive.

On page 5, strike in their entirety lines 1 through 14, inclusive; after line 14, insert:

“19-605.

AN INTERNATIONAL MARRIAGE BROKER MAY DISCLOSE INFORMATION ON A RECRUIT ONLY AFTER OBTAINING CONSENT FROM THE RECRUIT, WRITTEN IN THE RECRUIT’S NATIVE LANGUAGE.”;

in lines 15 and 20, strike “**19-605.**” and “**19-606.**”, respectively, and substitute “**19-606.**” and “**19-607.**”, respectively; and in line 23, after “**BOTH**” insert “**, IN ADDITION TO ANY PENALTY IMPOSED UNDER FEDERAL LAW**”.

AMENDMENT NO. 3

On page 6, in line 1, after “That” insert “, on or before December 1, 2010, the Department of Labor, Licensing, and Regulation, in consultation with the Department of Public Safety and Correctional Services, shall:”

(a) report on the feasibility of registering or licensing international marriage brokers;

(b) recommend whether to implement a registration or licensing scheme through legislation; and

(c) provide draft legislation to implement any recommended registration or licensing scheme.

SECTION 3. AND BE IT FURTHER ENACTED, That”.
