AMENDMENTS TO SENATE BILL 559

(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in the sponsor line, strike "and Stone" and substitute "Stone, Brochin, Jacobs, Raskin, and Simonaire".

AMENDMENT NO. 2

On page 1, in line 2, strike "Mandatory"; strike beginning with "Regularly" in line 2 down through the second "Abuse" in line 3 and substitute "Living with or in the Regular Presence of Registered Child Sexual Offenders"; in line 4, strike "requiring certain professionals" and substitute "authorizing an individual"; in lines 5 and 6, strike "professionals have" and substitute "individual has"; in line 7, strike "regularly associate with" and substitute "be in the regular presence of"; in lines 7 and 8, strike "providing certain exceptions" and substitute "providing for the manner of reporting"; in line 9, after the first "a" insert "certain"; in lines 9 and 10, strike "that a child is at substantial risk of abuse"; in line 11, strike "or" and substitute "and"; in line 14, strike "authorizing and"; in line 15, strike "after completion" and substitute "as part"; strike beginning with "providing" in line 15 down through "reports;" in line 16; in line 17, strike "mandatory"; in line 18, strike "regularly in contact" and substitute "living"; in the same line, after "with" insert "or in the regular presence of"; and in line 26, strike "5–707(b) and".

On page 2, strike in their entirety lines 1 through 21, inclusive.

AMENDMENT NO. 3

On page 2, strike beginning with "EXCEPT" in line 26 down through "SHALL" in line 30 and substitute "AN INDIVIDUAL MAY".

On page 3, strike in their entirety lines 1 through 27, inclusive.

AMENDMENT NO. 4

On page 2, in lines 33 and 34, strike "OR REGULARLY ASSOCIATE"; in line 34, after "WITH" insert "OR BE IN THE REGULAR PRESENCE OF"; and after line 35, insert:

"(1) IS REGISTERED UNDER TITLE 11, SUBTITLE 7 OF THE CRIMINAL PROCEDURE ARTICLE AS A CHILD SEXUAL OFFENDER; AND

(2) BASED ON ADDITIONAL INFORMATION, POSES A SUBSTANTIAL RISK OF SEXUAL ABUSE TO THE CHILD.".

On page 4 in lines 11, 12, 16, 18, and 22, on page 5, in lines 4 and 11, and on page 6 in line 28, in each instance, before "ABUSE" insert "SEXUAL".

On page 5, in line 5, strike "§ 5–704.1 OF"; and in line 15, strike "CHILD" and substitute "SEXUAL".

AMENDMENT NO. 5

On page 3, after line 27, insert:

"(B) (1) A REPORT UNDER SUBSECTION (A) OF THIS SECTION MAY BE ORAL OR IN WRITING.".

On page 4, in line 3, strike "(D)" and substitute "(C)".

AMENDMENT NO. 6

On page 4, in line 23, strike "(I)"; and strike in their entirety lines 26 through 29, inclusive.

Amendments to SB 559 Page 3 of 3

On page 5, in line 8, strike "TRUE" and substitute "ACCURATE AND THAT THERE IS SPECIFIC INFORMATION THAT THE CHILD IS AT SUBSTANTIAL RISK OF SEXUAL ABUSE"; in line 12, strike "MAY" and substitute "SHALL"; in line 20, strike "OR" and substitute "AND"; and in lines 23 and 24 and 29, in each instance, strike "HAVING A HISTORY OF ABUSE" and substitute "A CHILD SEXUAL OFFENDER".

AMENDMENT NO. 7

On page 5, in line 30, strike "(1)"; and in line 31, strike "WITHIN 10" and substitute "AS SOON AS PRACTICABLE BUT NOT LATER THAN 30".

On page 6, strike in their entirety lines 1 and 2.

AMENDMENT NO. 8

On page 6, strike in their entirety lines 3 through 13, inclusive, and substitute:

- "(E) AS PART OF THE INVESTIGATION, THE LOCAL DEPARTMENT SHALL:
 - (1) DETERMINE WHETHER THE CHILD IS SAFE;
- (2) <u>DETERMINE WHETHER SEXUAL ABUSE OF THE CHILD HAS</u> <u>OCCURRED</u>;
 - (3) IF APPROPRIATE, OFFER SERVICES TO THE FAMILY; AND
- (4) <u>IMMEDIATELY DECIDE WHETHER TO FILE A PETITION</u>
 ALLEGING THAT THE CHILD IS IN NEED OF ASSISTANCE.".

AMENDMENT NO. 9

On page 6, strike in their entirety lines 14 through 24, inclusive.
