FOR the purpose of altering the threshold for the phosphoric acid content of lawn fertilizers to which certain prohibitions and requirements apply; <u>altering a</u> <u>certain applicability date</u>; providing for a certain exception until a certain date; altering a certain definition; and generally relating to the regulation of low phosphorous fertilizer.
