1 AN ACT concerning

2 **Calvert County – Education – Junior Reserve Officer Training Corps**
3 **Instructors**

4 FOR the purpose of applying to Calvert County a certain definition of “public school
5 employee” that includes Junior Reserve Officer Training Corps (JROTC)
6 instructors for the purpose of certain provisions of law related to organizations
7 of certificated employees; and generally relating to representation for JROTC
8 instructors in Calvert County.

9 BY repealing and reenacting, with amendments,
10 Article – Education
11 Section 6–401(d)
12 Annotated Code of Maryland
13 (2008 Replacement Volume and 2009 Supplement)

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
15 MARYLAND, That the Laws of Maryland read as follows:

16 **Article – Education**

17 6–401.

18 (d) (1) “Public school employee” means a certificated professional
19 individual who is employed by a public school employer or an individual of equivalent
20 status in Baltimore City, except for a county superintendent or an individual

2 in § 6–408(b) of this subtitle.

3 (2) In Montgomery County, “public school employees” include:

4 (i) Certificated and noncertificated substitute teachers
5 employed by the public school employer for at least 7 days before March 1 of the school
6 fiscal year ending June 30, 1978, and each year after; and

7 (ii) Home and hospital teachers employed by the public school
8 employer for at least 7 days before March 1 of the school fiscal year ending June 30,
9 2000, and each year after.

10 (3) In Baltimore County, “public school employee” includes:

11 (i) A secondary school nurse, an elementary school nurse, and a
12 special school nurse; and

13 (ii) Supervisory noncertificated employees as defined under §
14 6–501(h) of this title.

15 (4) In Frederick County, “public school employee” includes a social
16 worker employed by a public school employer.

17 (5) In Prince George’s County, “public school employee” includes home
18 and hospital teachers and Junior Reserve Officer Training Corps (JROTC) instructors.

19 (6) In **CALVERT COUNTY**, Charles County, and Garrett County,
20 “public school employee” includes Junior Reserve Officer Training Corps (JROTC)
21 instructors.

22 (7) In Carroll County, “public school employee” includes:

23 (i) A registered nurse; and

24 (ii) Supervisory noncertificated employees as defined under §
25 6–501(h) of this title.

26 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
27 October 1, 2010.
