1 (f) (1) Except as provided in paragraphs (2) and (3) of this subsection, the 2 vendor shall deliver the completed disclosure or disclaimer statement required by this 3 section to the purchaser on or before entering into a contract of sale by the vendor and 4 the purchaser.

5 (2) The disclosure or disclaimer statement shall be delivered to each 6 purchaser before the execution of the contract of sale by the purchaser in the case of a 7 land installment contract, as defined in § 10–101 of this title.

8 (3) The disclosure or disclaimer statement shall be delivered to each 9 purchaser before the execution by the purchaser of an option to purchase agreement or 10 a lease agreement containing an option to purchase provision.

11 (4) At the time the disclosure or disclaimer statement is delivered, 12 each purchaser shall date and sign a written acknowledgment of receipt, which shall 13 be included in or attached to the contract of sale.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effectJuly 1, 2010.
