AND BE IT FURTHER ENACTED, That, on or before October 1, 2011, the Department of Labor, Licensing, and Regulation shall submit a report to the Senate Education, Health, and Environmental Affairs Committee and the House Economic Matters Committee, in accordance with § 2–1246 of the State Government Article, on:
- 23 (1) the status of efforts to restructure the Division of Occupational and 24 Professional Licensing to better serve the day–to–day operations of the State Board of 25 Plumbing, particularly related to the Board's complaint backlog and other 26 responsibilities;
- 27 (2) the Board's disposition of consumer complaints going back to at least fiscal year 2006, including the Board's effectiveness in resolving complaints in a 29 timely manner;
- 30 (3) the imposition of fines on licensees or individuals who engage in 31 malpractice, in particular the frequency and average amount of such fines and 32 whether or not industry regulation and consumer protection would benefit from 33 increasing fine amounts;
