# A BILL ENTITLED

## 1 AN ACT concerning

# 2 General Obligation Bonds for Capital Projects – Required Reports

3 FOR the purpose of requiring that an enabling act for certain projects that authorizes 4 the creation of a State debt for at least a certain amount to be used by certain  $\mathbf{5}$ entities contain a provision that requires the grantee to submit certain reports 6 to the Governor's Office of Minority Affairs by certain dates regarding the 7 extent to which the entity has used, or will use, certain funds for contracts with 8 minority-owned businesses; requiring that the Governor's Office of Minority 9 Affairs provide a certain form and annually report to certain committees of the 10 General Assembly on or before a certain date; providing for the termination of 11 this Act; and generally relating to the provisions of an enabling act authorizing the creation of a State debt. 12

18	(1) The Board of Public Works may borrow money and incur indebtedness on									

behalf of the State of Maryland through a State loan to be known as the ... (name of 1920project) Loan of ... (year) equal to the lesser of (i) \$... or (ii) the amount of the matching fund provided in accordance with Section 1(5) below. (For an enabling act that requires 2122an equal matching fund)/ in the total principal amount of \$..... (for an enabling act that 23requires no matching fund or a lesser matching fund). This loan shall be evidenced by the issuance, sale, and delivery of State general obligation bonds authorized by a 24resolution of the Board of Public Works and issued, sold, and delivered in accordance 25with §§ 8–117 through 8–124 of the State Finance and Procurement Article and Article 2631, § 22 of the Code. 27

28The bonds to evidence this loan or installments of this loan may be sold as (2)29a single issue or may be consolidated and sold as part of a single issue of bonds under § 8–122 of the State Finance and Procurement Article. 30

The cash proceeds of the sale of the bonds shall be paid to the Treasurer 31 (3)and first shall be applied to the payment of the expenses of issuing, selling, and 32delivering the bonds, unless funds for this purpose are otherwise provided, and then 33 34shall be credited on the books of the Comptroller and expended, on approval by the Board of Public Works, for the following public purposes, including any applicable 35 36 architects' and engineers' fees: as a grant to ..... (name of grantee) (referred to hereafter in this Act as "the grantee") (for an enabling act that requires a matching 37

1 fund) for (here state the purpose or purposes to which the proceeds of the bonds are to 2 be applied).

3 (4) An annual State tax is imposed on all assessable property in the State in 4 rate and amount sufficient to pay the principal of and interest on the bonds, as and 5 when due and until paid in full. The principal shall be discharged within 15 years after 6 the date of issue of the bonds.

9 (d) (1) If an enabling act requires an equal matching fund, the fifth 10 paragraph is as follows:

"(5) Prior to the payment of any funds under the provisions of this Act for the 11 12purposes set forth in Section 1(3) above, the grantee shall provide and expend a 13matching fund. No part of the grantee's matching fund may be provided, either 14directly or indirectly, from funds of the State, whether appropriated or unappropriated. No part of the fund may consist of real property, in kind 1516contributions, or funds expended prior to the effective date of this Act. In case of any dispute as to the amount of the matching fund or what money or assets may qualify as 17matching funds, the Board of Public Works shall determine the matter and the Board's 18 decision is final. The grantee has until June 1, ... (2 years from the effective date of the 1920Act), to present evidence satisfactory to the Board of Public Works that a matching fund will be provided. If satisfactory evidence is presented, the Board shall certify this 2122fact and the amount of the matching fund to the State Treasurer, and the proceeds of 23the loan equal to the amount of the matching fund shall be expended for the purposes provided in this Act. Any amount of the loan in excess of the amount of the matching 24fund certified by the Board of Public Works shall be canceled and be of no further 2526effect.".

27 (2) If an enabling act requires a lesser matching fund, the fifth 28 paragraph is as follows:

29Prior to the payment of any funds under the provisions of this Act for the "(5) purposes set forth in Section 1(3) above, the grantee shall provide and expend a 30 matching fund of \$ ..., (amount of the matching fund to be provided by the grantee). No 31 part of the grantee's matching fund may be provided, either directly or indirectly, from 32funds of the State, whether appropriated or unappropriated. No part of the fund may 33 consist of real property, in kind contributions, or funds expended prior to the effective 34 date of this Act. In case of any dispute as to the amount of the matching fund or what 35 36 money or assets may qualify as matching funds, the Board of Public Works shall 37 determine the matter and the Board's decision is final. The grantee has until June 1, 38... (2 years from the effective date of the Act), to present evidence satisfactory to the Board of Public Works that a matching fund will be provided. If satisfactory evidence 39 is presented, the Board shall certify this fact to the State Treasurer, and the proceeds 40 of the loan shall be expended for the purposes provided in this Act.". 41

- 1 (e) An enabling act may also contain the following paragraph:  $\mathbf{2}$ "The proceeds of the loan must be expended or encumbered by the Board of Public Works for the purposes provided in this Act no later than June 1, .... (7 years 3 from the effective date of the Act). If any funds authorized by this Act remain 4 unexpended or unencumbered after June 1, .... (7 years from the effective date of the  $\mathbf{5}$ Act), the amount of the unencumbered or unexpended authorization shall be canceled 6 7 and be of no further effect. 6 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 7 October 1, 2010. It shall remain effective for a period of 3 years and, at the end of 8 September 30, 2013, with no further action required by the General Assembly, this Act 9 shall be abrogated and of no further force and effect.
