#### HOUSE BILL 233

4 (F) THIS SECTION SHALL BE KNOWN AND MAY BE CITED AS THE 5 "HOWARD COUNTY PUBLIC SCHOOLS FUNDING ACCOUNTABILITY AND 6 TRANSPARENCY ACT".

7 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect8 October 1, 2010.
