FOR the purpose of adding a certain day to the list of public school holidays; removing
a certain day from the list of days for which public schools are required to
devote a part of the day to certain exercises; and generally relating to the
designation of Veterans Day as a public school holiday.

- 12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 13 MARYLAND, That the Laws of Maryland read as follows:

18 (1) (i) Shall be open for pupil attendance for at least 180 actual 19 school days and a minimum of 1,080 school hours during a 10-month period in each 20 school year; or

1 (e) (1) The county boards of Allegany, Anne Arundel, Calvert, Howard, 2 and Montgomery counties, and the Board of School Commissioners of Baltimore City, 3 may elect to operate one or more schools within the county or Baltimore City on a 4 year-round basis, provided that the 180-day and the minimum hour requirements 5 under this section are met.

6 (2) Nothing in this section precludes a county board from conducting a 7 year-round pilot study or program that is funded by the county board.

8 (f) Publicly funded prekindergarten programs are not subject to the 9 requirements of subsection (a) of this section.
