Commission on Surrogate Parenting

1 AN ACT concerning

3 FOR the purpose of creating the Commission on Surrogate Parenting; providing for 4 the composition, chair, and staffing of the Commission; providing that a 5 member of the Commission may not receive compensation but may be 6 reimbursed for certain expenses; requiring the Commission to study certain 7 issues related to surrogate parenting; requiring the Commission to make 8 certain recommendations, if possible; requiring the Commission to report 9 certain findings and recommendations to the Governor and to the General 10 Assembly; providing for the termination of this Act; and generally relating to the Commission on Surrogate Parenting. 11

- 12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 13 MARYLAND, That:
 - (a) There is a Commission on Surrogate Parenting.
- 15 (b) The Commission consists of the following members:
- 16 (1) three members of the Senate of Maryland, appointed by the 17 President of the Senate as follows:
- 18 (i) one member from the Judicial Proceedings Committee;
- 19 (ii) one member from the Finance Committee; and
- 20 (iii) one member from the Education, Health, and 21 Environmental Affairs Committee;

14 15 16 17	SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2010. It shall remain effective for a period of 1 year and 9 months and, at the end of March 31, 2012, with no further action required by the General Assembly, this Act shall be abrogated and of no further force and effect.
