#### HOUSE BILL 297

1 (3) At the end of a term, a member who is appointed under subsection 2 (b) of this section continues to serve until a successor is appointed and qualifies.

3 (4) A member who is appointed after a term has begun serves only for 4 the remainder of the term and until a successor is appointed and qualifies.

5 (d) Except for the three members appointed by the Secretary under 6 subsection (b) of this section, a member of the Commission may serve personally at a 7 Commission meeting or may designate a representative from the member's unit, 8 agency, or association who may act at any meeting to the same effect as if the member 9 were personally present.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
October 1, 2010.
