2 Business Regulation – Secondhand Precious Metal Object Dealers

- 3 FOR the purpose of repealing a certain provision of law authorizing a secondhand 4 precious metal object dealer to transact business for a certain period of time at a $\mathbf{5}$ certain event; providing that a license to do business as a dealer may be used 6 only to benefit the licensee; authorizing only licensed dealers to make certain 7advertisements; requiring a certain advertisement to include certain 8 information; requiring dealers to retain the original copy of a certain record at a 9 certain location; authorizing a dealer to request a certain extension; requiring 10 the Secretary of Labor, Licensing, and Regulation to distribute certain information to licensed dealers or post the information on the Department of 11 12Labor, Licensing, and Regulation website; and generally relating to regulation 13of secondhand precious metal object dealers.

10 11	(a) A license authorizes the licensee to do business as a dealer only at the address for which the license is issued.
12 13	(b) Notwithstanding subsection (a) of this section, [and except as provided in subsection (c) of this section,] a dealer who holds a license under this subtitle may:
14 15 16 17 18	(1) [transact business as a dealer for up to 7 consecutive days at an event that takes place at a location other than the fixed business address at which a transaction may occur after giving written notice at least 7 days in advance of the event to the primary law enforcement unit and to the local law enforcement unit with jurisdiction over the place where the event will be held;

1 (A) Each licensee shall display the license conspicuously in the place of 2 business of the licensee.

3 (B) (1) ONLY A LICENSED DEALER MAY ADVERTISE FOR THE 4 COMMERCIAL TRADING WITH THE PUBLIC OR ACQUIRING FROM THE PUBLIC IN 5 SECONDHAND PRECIOUS METAL OBJECTS.

6 (2) AN ADVERTISEMENT FOR THE COMMERCIAL TRADING WITH

(a) (1) Each dealer shall make a written record, on a form provided by the
 Secretary, of each business transaction that involves the acquisition of a secondhand
 precious metal object when the transaction is made.

16 (2) EACH DEALER SHALL RETAIN THE ORIGINAL COPY OF THE 17 WRITTEN RECORD REQUIRED TO BE MADE UNDER PARAGRAPH (1) OF THIS 18 SUBSECTION AT THE DEALER'S PLACE OF BUSINESS.

20 Unless otherwise authorized by the Secretary, a dealer shall keep the records 21 required by this subtitle, at a location within the State, for 3 years after the date of the 22 transaction.

(b) (1) [The] SUBJECT TO PARAGRAPH (2) OF THIS SUBSECTION, THE dealer shall submit the records by transmitting the required information from the records electronically, in a format acceptable to the receiving law enforcement unit, by noon of the next business day.

28 (2) A DEALER MAY REQUEST AN EXTENSION OF UP TO 48 HOURS 29 TO SUBMIT THE RECORDS REQUIRED UNDER PARAGRAPH (1) OF THIS 30 SUBSECTION.

32 (G) THE SECRETARY SHALL DISTRIBUTE TO LICENSED DEALERS OR 33 POST ON THE DEPARTMENT'S WEBSITE THE NAME OF THE PRIMARY LAW

1 ENFORCEMENT UNIT RESPONSIBLE FOR ENFORCING THIS TITLE IN EACH 2 JURISDICTION, INCLUDING MUNICIPALITIES.

3 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 4 October 1, 2010.
