Real Estate Investment Trusts - Miscellaneous Provisions

FOR the purpose of clarifying that a real estate investment trust may provide by its declaration of trust that holders of one or more classes or series of shares have exclusive voting rights on an amendment that would alter only the contract rights of those shareholders; providing that, without action by the shareholders, the majority of the entire board of trustees may amend the declaration of trust in any respect in which the charter of a corporation may be amended, unless prohibited in the declaration of trust in a certain manner; authorizing the board of trustees of certain real estate investment trusts to amend the declaration of trust, without shareholder action, to effect a certain reverse share split, unless prohibited in the declaration of trust in a certain manner; requiring a certain real estate investment trust to give certain notice of a certain reverse share split to certain shareholders within a certain time after the effective date of the reverse share split; authorizing a real estate investment trust to file a certain certificate of notice for record with the State Department of Assessments and Taxation; providing that a trustee of a real estate investment trust is not required to authorize or direct the filing of a certificate of notice; providing that a real estate investment trust is not required to file a certificate of notice; providing that a certificate of notice shall be executed in a certain manner; defining certain terms and altering a certain definition; and generally relating to real estate investment trusts.

(2) That any specified class of shares may be redeemed at the option of the real estate investment trust or of the holders of the shares and the terms and conditions of redemption, including the time and price of redemption;

- 1 (3) That any specified class of shares is convertible into shares of one 2 or more other classes and the terms and conditions of conversion;
- 3 (4) That the holders of any specified securities issued or to be issued 4 by the real estate investment trust have any voting or other rights which, by law, are 5 or may be conferred on shareholders;

- (5) THAT THE HOLDERS OF ONE OR MORE CLASSES OR SERIES OF SHARES HAVE EXCLUSIVE VOTING RIGHTS ON AN AMENDMENT TO THE DECLARATION OF TRUST THAT WOULD ALTER ONLY THE CONTRACT RIGHTS, AS EXPRESSLY SET FORTH IN THE DECLARATION OF TRUST, OF THE SPECIFIED CLASS OR SERIES OF SHARES;
- [(5)] (6) For any other preferences, rights, restrictions, including restrictions on transferability or ownership designed to permit the real estate investment trust to qualify under the Internal Revenue Code or regulations adopted under the Code or for any other purpose, and qualifications not inconsistent with law;
- [(6)] (7) That the board of trustees may classify or reclassify any unissued shares from time to time by setting or changing the preferences, conversion or other rights, voting powers, restrictions, limitations as to dividends or distributions, qualifications, or terms or conditions of redemption of the shares; and
- [(7)] (8) That the board of trustees may amend the declaration of trust to increase or decrease the aggregate number of shares or the number of shares of any class that the trust has authority to issue.
- 22 (c) (1) In this subsection, "facts ASCERTAINABLE OUTSIDE THE 23 DECLARATION OF TRUST" includes:

(2) Any of the preferences, conversion or other rights, voting powers, restrictions, limitations as to dividends or distributions, qualifications, or terms or conditions of redemption of any class or series of shares may be made dependent upon

- 31 (1) The PERMIT THE board of trustees, with the approval of two 32 thirds of its members, and without action by the shareholders, to amend the 33 declaration of trust from time to time to qualify as a real estate investment trust under the Internal Revenue Code or under this title [; and].

- 28 **[**(f)**]** (G) Articles of amendment shall be executed for the real estate investment trust in the manner required by § 1–301 of this article and filed for record with the Department.

- 4 OUTSIDE OF THE DECLARATION OF TRUST, AS DEFINED IN § 8-203(C) OF THIS
- 5 TITLE; OR
- 6 (3) ANY OTHER INFORMATION THAT THE REAL ESTATE 7 INVESTMENT TRUST DETERMINES SHOULD BE DISCLOSED.
- 8 (C) A CERTIFICATE OF NOTICE MAY NOT:
- 9 (1) AMEND, SUPPLEMENT, OR CORRECT THE DECLARATION OF 10 TRUST OF THE REAL ESTATE INVESTMENT TRUST IN ANY MANNER; OR
- 11 (2) AFFECT ANY RIGHTS OR LIABILITIES OF SHAREHOLDERS,
- 12 WHETHER OR NOT ACCRUED OR INCURRED BEFORE THE CERTIFICATE OF
- 13 NOTICE IS FILED.
- 14 (D) A CERTIFICATE OF NOTICE IS NOT A PART OF THE DECLARATION OF 15 TRUST OF A REAL ESTATE INVESTMENT TRUST.
- 16 **(E)** A TRUSTEE OF A REAL ESTATE INVESTMENT TRUST IS NOT REQUIRED TO AUTHORIZE OR DIRECT THE FILING OF A CERTIFICATE OF
- 18 NOTICE.
- 19 **(F)** A REAL ESTATE INVESTMENT TRUST IS NOT REQUIRED TO FILE A
- 20 CERTIFICATE OF NOTICE FOR ANY PURPOSE, INCLUDING TO INDICATE THAT
