A BILL ENTITLED

1 AN ACT concerning

Education - Character Education Fund

3 FOR the purpose of establishing the Character Education Fund in the State 4 Department of Education; requiring the Governor to include a certain amount 5 in the State budget each fiscal year for the Fund; establishing the grant 6 eligibility requirements for the Fund; requiring the Department to adopt certain 7 criteria for approving character education programs, decide whether to approve 8 a proposed character education program by certain dates, make certain grant 9 awards to county boards of education with approved character education 10 programs by certain dates and in certain amounts, devote a certain amount of 11 the Fund to certain activities, and establish certain reporting requirements; 12 requiring the Department to report to the Governor and the General Assembly 13 on or before certain dates; defining a certain term; and generally relating to the 14 Character Education Fund in the State Department of Education.

- 20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 21 MARYLAND, That the Laws of Maryland read as follows:
- 22 Article Education
- 23 **7–120.**
- 24 (A) IN THIS SECTION, "FUND" MEANS THE CHARACTER EDUCATION
- 25 **FUND.**

- 1 (B) THERE IS A CHARACTER EDUCATION FUND IN THE DEPARTMENT.
- 2 (C) THE PURPOSE OF THE FUND IS TO ENCOURAGE COUNTY BOARDS TO 3 FUND AND IMPLEMENT CHARACTER EDUCATION PROGRAMS.
- 4 (D) THE DEPARTMENT SHALL ADMINISTER THE FUND.
- 5 (E) (1) THE FUND IS A SPECIAL, NONLAPSING FUND THAT IS NOT 6 SUBJECT TO § 7–302 OF THE STATE FINANCE AND PROCUREMENT ARTICLE.
- 7 (2) THE TREASURER SHALL HOLD THE FUND SEPARATELY, AND 8 THE COMPTROLLER SHALL ACCOUNT FOR THE FUND.
- 9 (F) (1) THE FUND CONSISTS OF:
- 10 (I) MONEY APPROPRIATED IN THE STATE BUDGET TO THE
- 11 **FUND**;
- 12 (II) INVESTMENT EARNINGS OF THE FUND; AND
- 13 (III) ANY OTHER MONEY FROM ANY OTHER SOURCE 14 ACCEPTED FOR THE BENEFIT OF THE FUND.
- 15 (2) THE GOVERNOR SHALL INCLUDE \$100,000 IN THE STATE
- 16 BUDGET EACH FISCAL YEAR FOR THE FUND.
- 17 (G) THE FUND MAY BE USED ONLY:
- 18 (1) TO PROVIDE MATCHING GRANTS TO COUNTY BOARDS TO
- 19 IMPLEMENT CHARACTER EDUCATION PROGRAMS APPROVED BY THE
- 20 **DEPARTMENT; AND**
- 21 (2) TO PAY UP TO \$25,000 ANNUALLY FOR PROGRAM
- 22 ADMINISTRATION, PROFESSIONAL DEVELOPMENT, AND TECHNICAL ASSISTANCE
- 23 TO LOCAL SCHOOL SYSTEMS WITH CHARACTER EDUCATION PROGRAMS THAT
- 24 RECEIVED GRANTS FROM THE FUND.
- 25 (H) (1) THE TREASURER SHALL INVEST THE MONEY OF THE FUND IN
- 26 THE SAME MANNER AS OTHER STATE MONEY MAY BE INVESTED.
- 27 (2) ANY INVESTMENT EARNINGS OF THE FUND SHALL BE
- 28 CREDITED TO THE FUND.

- 1 (I) EXPENDITURES FROM THE FUND MAY BE MADE ONLY IN 2 ACCORDANCE WITH THE STATE BUDGET.
- 3 (J) TO BE ELIGIBLE TO RECEIVE A GRANT FROM THE FUND, A COUNTY
 4 BOARD SHALL SUBMIT A DESCRIPTION OF THE PROPOSED CHARACTER
 5 EDUCATION PROGRAM TO THE DEPARTMENT BY JUNE 1 PRECEDING THE
 6 SCHOOL YEAR IN WHICH THE CHARACTER EDUCATION PROGRAM WILL BE
 7 IMPLEMENTED.

(K) THE DEPARTMENT SHALL:

- 9 (1) ADOPT CRITERIA FOR APPROVING CHARACTER EDUCATION 10 PROGRAMS;
- 11 (2) DECIDE WHETHER TO APPROVE A PROPOSED CHARACTER
 12 EDUCATION PROGRAM BY JULY 1 PRECEDING THE SCHOOL YEAR IN WHICH A
 13 CHARACTER EDUCATION PROGRAM WILL BE IMPLEMENTED;
- 14 (3) AWARD, BY JULY 1 PRECEDING THE SCHOOL YEAR IN WHICH
 15 A CHARACTER EDUCATION PROGRAM WILL BE IMPLEMENTED, A GRANT TO THE
 16 FIVE COUNTY BOARDS WITH THE HIGHEST NUMBER OF STUDENT SUSPENSIONS
 17 DURING THE 2008–2009 SCHOOL YEAR AS REPORTED BY THE DEPARTMENT
 18 WITH AN APPROVED CHARACTER EDUCATION PROGRAM EQUAL TO THE LESSER
 19 OF:
- 20 (I) THE AMOUNT OF MONEY THE FIVE ELIGIBLE COUNTY 21 BOARDS HAVE APPROPRIATED FOR THE CHARACTER EDUCATION PROGRAM; OR
- 22 (II) THE PRODUCT OF THE AMOUNT OF MONEY IN THE 23 FUND AT THE START OF THE FISCAL YEAR AND THE PERCENTAGE OF THE 24 NUMBER OF STUDENTS ENROLLED IN THE PUBLIC SCHOOLS OF THE ELIGIBLE 25 FIVE COUNTIES IN THE STATE THAT ATTEND ELIGIBLE PUBLIC SCHOOLS IN THE 26 COUNTY; AND
- 27 (4) ESTABLISH REPORTING REQUIREMENTS THAT ARE ALIGNED
 28 WITH THE CRITERIA TO BE ESTABLISHED FOR CHARACTER EDUCATION
 29 PROGRAMS BY THE DEPARTMENT, INCLUDING, BUT NOT LIMITED TO, ACADEMIC
 30 ACHIEVEMENT, SCHOOL CLIMATE, AND THE DEVELOPMENT OF IDENTIFIED
 31 SOCIAL SKILLS.
- 32 (L) THE DEPARTMENT SHALL REPORT TO THE GOVERNOR AND TO THE 33 GENERAL ASSEMBLY ON OR BEFORE NOVEMBER 1 OF EACH YEAR, IN ACCORDANCE WITH § 2–1246 OF THE STATE GOVERNMENT ARTICLE, ON THE

- 1 DISTRIBUTION OF GRANTS FROM THE FUND AND THE IMPACT OF THE GRANTS
- 2 ON CHARACTER EDUCATION IN THE STATE FOR THE PRIOR SCHOOL YEAR.
- 3 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 4 July 1, 2010.
