A BILL ENTITLED

1 AN ACT concerning

2 Crimes - Indecent Exposure and Possession of Child Pornography - Offender 3 Registration

- 4 FOR the purpose of providing that the possession of a certain digital image showing an $\mathbf{5}$ actual child under a certain age in certain circumstances is a criminal offense; 6 repealing a certain provision that provides that it is an affirmative defense to a 7 certain violation if a person takes reasonable steps to destroy a certain visual 8 representation; altering the definition of "offender" to require a person to 9 register on a certain offender registry if they are ordered to register by the court 10 and if the person has been convicted of the offense of indecent exposure if the 11 offense occurred in the presence of an individual under a certain age or a certain offense relating to the possession of certain visual representations; and 12generally relating to indecent exposure and child pornography. 13

6 7	A person convicted of indecent exposure is guilty of a misdemeanor and is subject to imprisonment not exceeding 3 years or a fine not exceeding \$1,000 or both.

$\begin{array}{c} 28\\ 29 \end{array}$	(1) for a first violation, imprisonment not exceeding 10 years or a fine not exceeding \$25,000 or both; and
$\begin{array}{c} 30\\ 31 \end{array}$	(2) for each subsequent violation, imprisonment not exceeding 20 years or a fine not exceeding \$50,000 or both.

22	(3) in a state of sexual excitement.
