1 AN ACT concerning

2 **Child Support Guidelines – Revision**

3 FOR the purpose of revising the schedule of basic child support obligations used to
4 calculate the amount of a child support award under the child support
5 guidelines; repealing provisions of law establishing that the adoption or revision
6 of the child support guidelines may be grounds for requesting a modification of a
7 child support award based on a material change in circumstances under certain
8 circumstances; establishing that the adoption or revision of the child support
9 guidelines is not a material change of circumstance for the purpose of a
10 modification of a child support award; defining certain terms; making certain
11 clarifying and conforming changes; ~~providing for a delayed effective date;~~ and
12 generally relating to child support.

10 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
11 MARYLAND, That the Laws of Maryland read as follows:

12 **Article – Family Law**

13 12–201.

14 **(J) “OBLIGEE” MEANS ANY PERSON WHO IS ENTITLED TO RECEIVE**
15 **CHILD SUPPORT.**

16 **(K) “OBLIGOR” MEANS AN INDIVIDUAL WHO IS REQUIRED TO PAY CHILD**
17 **SUPPORT UNDER A COURT ORDER.**

18 **[(j)] (L)** “Potential income” means income attributed to a parent
19 determined by the parent’s employment potential and probable earnings level based
20 on, but not limited to, recent work history, occupational qualifications, prevailing job
21 opportunities, and earnings levels in the community.

22 **[(k)] (M)** (1) “Shared physical custody” means that each parent keeps the
23 child or children overnight for more than 35% of the year and that both parents
24 contribute to the expenses of the child or children in addition to the payment of child
25 support.

26 (2) Subject to paragraph (1) of this subsection, the court may base a
27 child support award on shared physical custody:

28 (i) solely on the amount of visitation awarded; and

29 (ii) regardless of whether joint custody has been granted.

31 (a) (1) Subject to the provisions of paragraph (2) of this subsection, in any
32 proceeding to establish or modify child support, whether pendente lite or permanent,
33 the court shall use the child support guidelines set forth in this subtitle.

1 (2) (i) There is a rebuttable presumption that the amount of child
2 support which would result from the application of the child support guidelines set
3 forth in this subtitle is the correct amount of child support to be awarded.

4 (ii) The presumption may be rebutted by evidence that the
5 application of the guidelines would be unjust or inappropriate in a particular case.

6 (iii) In determining whether the application of the guidelines
7 would be unjust or inappropriate in a particular case, the court may consider:

8 1. the terms of any existing separation or property
9 settlement agreement or court order, including any provisions for payment of
10 mortgages or marital debts, payment of college education expenses, the terms of any
11 use and possession order or right to occupy the family home under an agreement, any
12 direct payments made for the benefit of the children required by agreement or order,
13 or any other financial considerations set out in an existing separation or property
14 settlement agreement or court order; and

15 2. the presence in the household of either parent of other
16 children to whom that parent owes a duty of support and the expenses for whom that
17 parent is directly contributing.

18 (iv) The presumption may not be rebutted solely on the basis of
19 evidence of the presence in the household of either parent of other children to whom
20 that parent owes a duty of support and the expenses for whom that parent is directly
21 contributing.

22 (v) 1. If the court determines that the application of the
23 guidelines would be unjust or inappropriate in a particular case, the court shall make
24 a written finding or specific finding on the record stating the reasons for departing
25 from the guidelines.

26 2. The court's finding shall state:

27 A. the amount of child support that would have been
28 required under the guidelines;

29 B. how the order varies from the guidelines;

30 C. how the finding serves the best interests of the child;
31 and

32 D. in cases in which items of value are conveyed instead
33 of a portion of the support presumed under the guidelines, the estimated value of the
34 items conveyed.

(b) [(1) Subject to the provisions of paragraph (2) of this subsection, the THE adoption or revision of the guidelines set forth in this subtitle [may be grounds for requesting a modification of a child support award based on a material change in circumstances] IS NOT A MATERIAL CHANGE OF CIRCUMSTANCE FOR THE PURPOSE OF A MODIFICATION OF A CHILD SUPPORT AWARD.

[(2) The adoption or revision of the guidelines set forth in this subtitle may not be grounds for requesting a modification of a child support award based on a material change in circumstances unless the use of the guidelines would result in a change in the award of 25% or more.]

(c) On or before January 1, 1993, and at least every 4 years after that date, the Child Support Enforcement Administration of the Department of Human Resources shall:

(1) review the guidelines set forth in this subtitle to ensure that the application of the guidelines results in the determination of appropriate child support award amounts; and

(2) report its findings and recommendations to the General Assembly, subject to § 2-1246 of the State Government Article.

9 (g) (1) Subject to paragraphs (2) and (3) of this subsection, actual child
 10 care expenses incurred on behalf of a child due to employment or job search of either
 11 parent shall be added to the basic obligation and shall be divided between the parents
 12 in proportion to their adjusted actual incomes.

13 (2) Child care expenses shall be:

14 (i) determined by actual family experience, unless the court
 15 determines that the actual family experience is not in the best interest of the child; or

16 (ii) if there is no actual family experience or if the court
 17 determines that actual family experience is not in the best interest of the child:

18 1. the level required to provide quality care from a
 19 licensed source; or

20 2. if the [custodial parent] **OBLIGEE** chooses quality
 21 child care with an actual cost of an amount less than the level required to provide
 22 quality care from a licensed source, the actual cost of the child care expense.

23 (3) Additional child care expenses may be considered if a child has
 24 special needs.

25 (l) (1) Except in cases of shared physical custody, each parent's child
 26 support obligation shall be determined by adding each parent's respective share of the
 27 basic child support obligation, work-related child care expenses, health insurance
 28 expenses, extraordinary medical expenses, and additional expenses under subsection
 29 (i) of this section.

30 (2) The [custodial parent] **OBLIGEE** shall be presumed to spend that
 31 parent's total child support obligation directly on the child or children.

32 (3) The [noncustodial parent] **OBLIGOR** shall owe that parent's total
 33 child support obligation as child support to the [custodial parent] **OBLIGEE** minus any
 34 ordered payments included in the calculations made directly by the [noncustodial
 35 parent] **OBLIGOR** on behalf of the child or children for work-related child care

1 expenses, health insurance expenses, extraordinary medical expenses, or additional
2 expenses under subsection (i) of this section.

3 (m) (1) In cases of shared physical custody, the adjusted basic child
4 support obligation shall first be divided between the parents in proportion to their
5 respective adjusted actual incomes.

6 (2) Each parent's share of the adjusted basic child support obligation
7 shall then be multiplied by the percentage of time the child or children spend with the
8 other parent to determine the theoretical basic child support obligation owed to the
9 other parent.

10 (3) Subject to the provisions of paragraphs (4) and (5) of this
11 subsection, the parent owing the greater amount under paragraph (2) of this
12 subsection shall owe the difference in the 2 amounts as child support.

13 (4) In addition to the amount of the child support owed under
14 paragraph (3) of this subsection, if either parent incurs child care expenses under
15 subsection (g) of this section, health insurance expenses under subsection (h)(1) of this
16 section, extraordinary medical expenses under subsection (h)(2) of this section, or
17 additional expenses under subsection (i) of this section, the expense shall be divided
18 between the parents in proportion to their respective adjusted actual incomes. The
19 parent not incurring the expense shall pay that parent's proportionate share to:

20 (i) the parent making direct payments to the provider of the
21 service; or

22 (ii) the provider directly, if a court order requires direct
23 payments to the provider.

24 (5) The amount owed under paragraph (3) of this subsection may not
25 exceed the amount that would be owed under subsection (l) of this section [if the
26 obligor parent were a noncustodial parent].

27 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
