A BILL ENTITLED

1 AN ACT concerning

2 **St. Mary's County – Annual Financial Report – Filing Date**

3 FOR the purpose of altering the date by which St. Mary's County may file its annual
4 financial report for the fiscal year with the Department of Legislative Services;
5 and generally relating to the annual financial report of St. Mary's County.

6 BY repealing and reenacting, with amendments,
7 Article 19 – Comptroller

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
12 MARYLAND, That the Laws of Maryland read as follows:

13 **Article 19 – Comptroller**

14 37.

15 (a) (1) Except as provided in paragraph (2) of this subsection, each
16 county, municipal corporation, and taxing district in the State shall by the first day of
17 November after the close of the fiscal year file with the Department of Legislative
18 Services its financial report covering the full period of that fiscal year.

19 (2) (i) Each county, municipal corporation, or taxing district with a
20 population of more than 400,000 may by the first day of January after the close of the
21 fiscal year file with the Department of Legislative Services its financial report
22 covering the full period of that fiscal year.

23 (ii) Unless subparagraph (i) of this paragraph applies, Howard
24 County may by the first day of December after the close of the fiscal year file with the

1 Department of Legislative Services its financial report covering the full period of that
2 fiscal year.

3 (iii) Frederick County may by the first day of January after the
4 close of the fiscal year file with the Department of Legislative Services its financial
5 report covering the full period of that fiscal year.

6 (iv) **ST. MARY'S COUNTY MAY BY THE FIRST DAY OF**
7 **JANUARY AFTER THE CLOSE OF THE FISCAL YEAR FILE WITH THE DEPARTMENT**
8 **OF LEGISLATIVE SERVICES ITS FINANCIAL REPORT COVERING THE FULL**
9 **PERIOD OF THAT FISCAL YEAR.**

10 (v) Wicomico County may by the first day of January after the
11 close of the fiscal year file with the Department of Legislative Services its financial
12 report covering the full period of that fiscal year.

13 (b) The reports required by subsection (a) of this section shall be:

14 (1) Properly filled in on the form or forms established by the
15 Department as provided in this subtitle; and

16 (2) Verified by the chief executive officer of each county, municipal
17 corporation, and taxing district.

18 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
19 October 1, 2010.
