BE IT ENACTED BY THE GENERAL ASSEMBLY OF 11 MARYLAND, That the Laws of Maryland read as follows: 12 **Article - Natural Resources** 13 14 8-721. In this section, "abandoned vessel" means any vessel that: 15 (a) 16 (1) Is left illegally or has remained without permission for more than 17 30 days on public property, including public marinas, docks, or boatyards;
