4 FOR the purpose of creating in Wicomico County a beer tasting (BT) license and a 5 beer/wine tasting (BWT) license; specifying to whom the licenses may be issued; 6 providing for license fees, applications, renewals, and issuance procedures; 7 setting certain maximum limits on the amounts of individual servings and open 8 containers and bottles of beer and wine at certain events; specifying certain 9 restrictions and notice requirements on certain beer or wine events; authorizing 10 the Board of License Commissioners to adopt certain regulations; authorizing a 11 person of a certain age who has a valid work permit to be employed for certain 12 purposes at premises that are licensed to sell alcoholic beverages in Wicomico 13 County; making certain stylistic changes; and generally relating to alcoholic 14 beverages in Wicomico County.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF 3 MARYLAND, That the Laws of Maryland read as follows: 4 Article 2B - Alcoholic Beverages 5 6-101.6 (a) A Class A beer, wine and liquor license shall be issued by the (1) 7 license issuing authority of the county in which the place of business is located. The 8 license authorizes the holder to keep for sale and to sell all alcoholic beverages at 9 retail, in any quantity, at the place described in the license. The licensee shall deliver 10 the alcoholic beverages in a sealed package or container and the package or container may not be opened nor its contents consumed on the premises where sold. 11 12 (x) This subsection applies only in Wicomico County. (1) 13 (5)(i) [1.]The annual license fee is [\$2,200. 2. 14 During calendar year 1997, the annual license fee is 15 \$3,300. 16 3. During calendar year 1998 and thereafter, the annual 17 license fee is \$4,400. 6-401.18 19 A Class D beer, wine and liquor license shall be issued by the 20 license issuing authority of the county in which the place of business is located. It 21authorizes the holder to keep for sale and sell all alcoholic beverages at retail at the 22 place described in it, for consumption on the premises or elsewhere. A license may not 23be issued for any drugstore. 24(1) This subsection applies only in Wicomico County. (x) 25 A person may not be on the premises who is under the legal 26 **DRINKING** age I for the consumption of beer and light wine in this State. 27 8-412.28 This section applies only in Wicomico County. (a) 29 (b) (1) The Board of License Commissioners may issue [a]:

3 4	(III) A BEER/WINE TASTING (BWT) LICENSE FOR BEER OR WINE TASTING AND SAMPLING.
5 6 7	(2) A BT, WT, OR BWT license may be issued only to a holder of a Class A beer and wine (off-sale) license OR TO A HOLDER OF A CLASS A BEER, WINE AND LIQUOR (OFF-SALE) LICENSE.
8	(c) The annual [WT] license fee is [\$150]:
9	(I) FOR A BT LICENSE, \$150;
10	(II) FOR A WT LICENSE, \$150; AND
11	(III) FOR A BWT LICENSE, \$250.
12 13	(d) (1) An application for a BT , WT, OR BWT license shall be made on a form that the Board of License Commissioners provides.
14 15 16	(2) A renewal of the BT , WT, OR BWT license may be made at the time the Class A beer and wine (off-sale) license OR CLASS A BEER , WINE AND LIQUOR (OFF-SALE) LICENSE is renewed.
17 18	(3) The Board of License Commissioners may grant a BT , WT, OR BWT license without a hearing.
19 20	(4) If application for a BT , WT, OR BWT license is denied, the applicant may request a public hearing before the Board of License Commissioners.
21 22 23	(e) (1) [A WT license holder may not serve to any person for sampling or tasting purposes more than 1 ounce from each brand] FOR SAMPLING OR TASTING PURPOSES, A PERSON MAY NOT BE SERVED MORE THAN:
24	(I) 3 OUNCES FROM EACH BRAND OF BEER; OR
25	(II) 1 OUNCE FROM EACH BRAND OF WINE.
26 27	(2) (I) A MAXIMUM OF SIX CONTAINERS OF BEER MAY BE OPEN AT ANY ONE TIME AT A BEER SAMPLING OR TASTING EVENT.
28	(II) A maximum of six bottles OF WINE may be open at any one

time at a wine sampling or tasting event.

- 1 (3) The total number of days during which **BEER OR** wine sampling or tasting events are held may not exceed 15 in any period for which a **BT**, WT, **OR** 3 **BWT** license is in effect.
- 4 (4) A **BT**, WT, **OR BWT** license holder shall notify the Board of License Commissioners in writing at least 5 days before a **BEER OR** wine sampling or tasting event.
- 7 (5) Once opened, each **CONTAINER OR** bottle used for a **BEER OR** 8 wine sampling or tasting event shall be marked that it is to be used for that purpose only.
- 10 (6) The contents of each **CONTAINER OR** bottle may not be mixed with any other **CONTAINER OR** bottle, and all **CONTAINERS AND** bottles shall be destroyed once they are empty.
- 13 (f) (1) A **BT**, WT, **OR BWT** license is for on–premises consumption only.
- 14 (2) [Wine] **BEER OR WINE** sampling or tasting may not be conducted 15 from a drive—through window.
- 16 (G) THE BOARD OF LICENSE COMMISSIONERS MAY ADOPT 17 REGULATIONS TO CARRY OUT THIS SECTION.

- 19 (a) Unless provision is made elsewhere, the following provisions apply 20 statewide to persons who are employed in licensed establishments:
- 21 (1) A person under age 18 may not be engaged in the sale of alcoholic 22 beverages.
- 23 (2) Except for Class D beer, wine and liquor licensees as provided in paragraph (3) of this subsection, a person between ages 18 and 21 may be employed in the sale of beer and light wine.
- 26 (3) A person under age 21 may not be employed by any holder of a Class D beer, wine and liquor license in the sale of alcoholic beverages.
- 28 (4) A person 18 years old and older may be employed by a Class A licensee to operate a lottery ticket terminal.
- 30 (b) In the following jurisdictions the specified exceptions to subsection (a) of 31 this section apply:

1	(13) IN WICOMICO COUNTY A PERSON WHO IS AT LEAST 16 YEARS
2	OLD AND HAS A WORK PERMIT MAY BE EMPLOYED AT A LICENSED PREMISES TO
3	STOCK ALCOHOLIC BEVERAGES OR CLEAR TABLES AND BAR AREAS.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 5 $\,$ July 1, 2010.
