A BILL ENTITLED AN ACT concerning 1 2 Baltimore County - Property Tax Credit - Rosewald Beach Civic League 3 FOR the purpose of authorizing the governing body of Baltimore County to grant, by law, a property tax credit against the county tax imposed on real property 4 5 owned by the Rosewald Beach Civic League; providing for the application of this 6 Act; and generally relating to a property tax credit in Baltimore County for the 7 Rosewald Beach Civic League. 8 BY repealing and reenacting, with amendments, 9 Article – Tax – Property Section 9-305(b)10 Annotated Code of Maryland 11 12 (2007 Replacement Volume and 2009 Supplement) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 13 MARYLAND, That the Laws of Maryland read as follows: 14 15 Article - Tax - Property 16 9 - 305.17 The governing body of Baltimore County may grant, by law, a property 18 tax credit under this section against the county property tax imposed on: 19 (1) real property that is owned by the Twin River Protective and 20 Improvement Association, Incorporated; 21**(2)** real property that is owned by the Bowley's Quarters Improvement 22 Association, Incorporated;
