CHAPTER _____

1 AN ACT concerning

2 **Registered Nurses, Licensed Practical Nurses, Nursing Assistants, and**
3 **Medication Technicians – Changes to Licensure Requirements**

4 FOR the purpose of requiring that if the State Board of Nursing has reason to believe
5 and objective evidence that a certain applicant, licensee, or certificate holder
6 may cause harm to certain individuals, the Board require the applicant,
7 licensee, or certificate holder to submit to a certain examination; adding certain
8 individuals who have applied for a certain license, have passed a certain
9 examination, and are awaiting receipt of certain criminal history record
10 information to those individuals who are exempt from certain licensure
11 requirements; adding certain individuals who provide gratuitous care for
12 friends and family to those individuals who are exempt from certain licensure
13 requirements; requiring that certain applicants pass a certain national
14 examination; providing that practicing nursing in certain states or territories
15 for at least a certain number of years is acceptable proof of proficiency in
16 English; repealing the requirement that the Board give certain examinations;
17 requiring the Board to issue certain licensees and certificate holders a license or
18 certification number and a registration certificate that indicates certain
19 information; requiring the Board to record electronically certain licenses and
20 certificates, including inactive status, in certain databases and on certain
21 websites; extending the period of time the Board has to send certain renewal
22 notices; altering the term of certain licenses; authorizing the Board to send
23 certain renewal notices by electronic means; requiring the Board to send certain
24 renewal applicants certain documents necessary for initiating criminal history

22 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
 23 MARYLAND, That the Laws of Maryland read as follows:

24 **Article – Health Occupations**

25 8–205.1.

26 (a) If the Board, while **REVIEWING AN APPLICATION FOR LICENSURE OR**
 27 investigating an allegation brought against a licensee under this title, has reason to
 28 believe **AND OBJECTIVE EVIDENCE** that the **APPLICANT OR** licensee may cause
 29 harm to individuals affected by the **APPLICANT’S OR** licensee’s practice of nursing,
 30 the Board shall require the **APPLICANT OR** licensee to submit to an appropriate
 31 examination by a health care provider designated by the Board.

32 (b) In return for the privilege [given to a licensee] to practice nursing in the
 33 State, the **APPLICANT OR** licensee is deemed to have:

34 (1) Consented to submit to an examination under this section, if
 35 requested by the Board in writing; and

36 (2) Waived any claim of privilege as to the testimony or examination
 37 reports of the examining health care professional.

1 (c) The failure or refusal of the **APPLICANT OR** licensee to submit to an
2 examination required under subsection (b) of this section is prima facie evidence of the
3 **APPLICANT'S OR** licensee's inability to practice nursing competently, unless the
4 Board finds that the failure or refusal was beyond the control of the licensee.

5 (d) The Board shall pay the cost of any examination made under this section.

7 (c) This section does not apply to:

8 (1) A student enrolled in an approved education program while
9 practicing registered nursing or licensed practical nursing in that program;

10 (2) An individual employed by the federal government to practice
11 registered nursing or licensed practical nursing while practicing within the scope of
12 that employment, if the individual is authorized by any state to practice registered
13 nursing or licensed practical nursing;

14 (3) An individual permitted to practice registered nursing or licensed
15 practical nursing under rules and regulations adopted by the Board, if the individual:

16 (i) Otherwise has qualified to practice registered nursing or
17 licensed practical nursing in any other state or country and is in this State
18 temporarily; or

19 (ii) Has an application for a license pending before the Board:

20 1. But has not taken the examination required under
21 this title; [or]

22 2. Has taken an examination under this title, but the
23 results of the examination are not yet known; [and] **OR**

24 **3. HAS TAKEN AND PASSED ~~THE~~ AN EXAMINATION**
25 **~~REQUIRED~~ UNDER THIS TITLE ~~AND~~, BUT IS WAITING FOR THE COMPLETION OF**
26 **THE CRIMINAL HISTORY ~~RECORD INFORMATION~~ RECORDS CHECK;**

27 **(4) AN INDIVIDUAL WHO PROVIDES GRATUITOUS CARE FOR**
28 **FRIENDS OR FAMILY; OR**

29 **[(4)] (5)** An individual who is assigned by the American Red Cross to
30 a disaster situation in this State to practice registered nursing or licensed practical
31 nursing, if the individual is licensed to practice registered nursing or licensed practical
32 nursing in another state.

1 (e) Except as otherwise provided in this title, the applicant shall pass an
2 examination [approved by the Board] **DEVELOPED BY THE NATIONAL COUNCIL OF**
3 **STATE BOARDS OF NURSING AND ADMINISTERED AT A TESTING SITE APPROVED**
4 **BY THE NATIONAL COUNCIL.**

5 (f) (2) [Graduation from a recognized English-speaking undergraduate
6 school after at least 3 years of enrollment, or from a recognized English-speaking
7 professional school is acceptable as] **ACCEPTABLE** proof of proficiency in the oral

23 more years prior to passing the licensure examination and who has not practiced for at
24 least 1,000 hours in the previous 5 years may only be issued an inactive license until
25 submission to the Board of satisfactory evidence that the applicant has successfully
26 completed:

27 (1) A nursing review course approved by the Board; or

28 (2) A preceptorship program provided by an employer and approved by
29 the Board.

30 [(f)] (E) (1) Except as provided in paragraph (2) of this subsection, an
31 applicant who fails an examination may retake the examination if the applicant pays
32 the reexamination fee set by the Board for each reexamination.

1 (2) The Board, by rule or regulation, may limit the number of times
2 that an applicant may be reexamined after two failures and may limit the interval of
3 time between reexaminations.

8 (2) A licensed practical nurse under this title.

24 nursing practice within the 5–year period immediately preceding the date of
25 anticipated renewal; or

26 (ii) Chooses inactive status;

19 (c) Before a license expires, the licensee periodically may renew it for an
 20 additional term, if the licensee:

21 (1) Otherwise is entitled to be licensed;

22 (2) Pays to the Board:

23 (i) A renewal fee set by the Board; or

24 (ii) A renewal fee that is set by the Board if the licensee certifies
 25 to the Board that the licensee provides professional services only as a volunteer; and

26 (3) Submits to the Board **BY PAPER APPLICATION OR ELECTRONIC**
 27 **MEANS:**

28 (i) A renewal application on the form that the Board requires;
 29 and

30 (ii) Satisfactory evidence of completion of:

1 1. 1,000 hours of active nursing practice within the
2 5-year period immediately preceding the date of renewal;

4 refresher course, approved by the Board; or

5 3. A preceptorship program provided by an employer
6 and approved by the Board.

6 (i) Has met the appropriate certification requirements of this
7 subtitle to the satisfaction of the Board;

8 (ii) Does not have a criminal record and has not been the subject
9 of a health professional disciplinary action in this State or another jurisdiction; and

10 (iii) Does not have a criminal charge or a health professional
11 disciplinary action pending in this State or another jurisdiction.

12 (2) Unless the Board suspends or revokes a temporary practice
13 certificate, the temporary practice certificate expires 90 days after issuance.

14 (3) A temporary practice certificate may be extended up to an
15 additional 90 days if the applicant is awaiting the completion of criminal history
16 record information.

17 **[(g)] (H)** A medication technician graduate may practice for no more than
18 90 days from the date of completion of a medication technician training program
19 without certification by the Board.

20 **[(h)] (I)** (1) On receipt of the criminal history record information of an
21 applicant for certification as a certified nursing assistant forwarded to the Board in
22 accordance with § 8–303 of this title, in determining whether to grant a certificate, the
23 Board shall consider:

24 (i) The age at which the crime was committed;

25 (ii) The circumstances surrounding the crime;

26 (iii) The length of time that has passed since the crime;

27 (iv) Subsequent work history;

28 (v) Employment and character references; and

29 (vi) Other evidence that demonstrates whether the applicant
30 poses a threat to the public health or safety.

26 Board requires;

27 (3) Pays to the Board a renewal fee set by the Board; and

28 (4) Provides satisfactory evidence of completion of:

29 (i) 16 hours of active nursing assistant practice within the
30 2-year period immediately preceding the date of renewal; or

1 (ii) An approved nursing assistant training program.

2 [(d) In addition to the requirements in subsection (c)(1), (2), and (3) of this
3 section, a skilled nursing assistant shall:

4 (1) Provide satisfactory evidence of completion of 1,000 hours of
5 practice as a skilled nursing assistant within the individual's specific category of
6 nursing assistant, in the 2-year period preceding the date of renewal; and

7 (2) Successfully complete a Board-approved refresher course within
8 the individual's specific category of nursing assistant.]

9 [(e) (D) In addition to the requirements in subsection (c)(1), (2), and (3) of
10 this section, a certified medicine aide shall:

11 (1) Provide satisfactory evidence of completion of 100 hours of practice
12 as a certified medicine aide in the 2-year period preceding the date of renewal; and

13 (2) Successfully complete a Board-approved medicine aide continuing
14 education program.

15 [(f) (E) Before a certificate expires, a medication technician periodically
16 may renew it for an additional term, if the certificate holder:

17 (1) Otherwise is entitled to be certified;

18 (2) Submits to the Board a renewal application on the form that the
19 Board requires;

20 (3) Pays to the Board a renewal fee set by the Board;

21 (4) Every 2 years, provides satisfactory evidence of completion of a
22 Board-approved clinical refresher course; and

23 (5) Provides satisfactory evidence of completion of 100 hours of
24 practice as a certified medication technician within the 2-year period preceding the
25 date of renewal.

26 [(g) (F) (1) The Board may grant a 30-day extension, beyond a
27 certificate's expiration date, to a certificate holder so that the certificate holder may
28 renew the certificate before it expires.

29 (2) The Board may grant two 90-day extensions beyond a certificate's
30 expiration date pending receipt of criminal history record information.

1 **[(h)] (G)** The Board shall reinstate the certificate of a former certificate
2 holder who has failed to renew the certificate for any reason if the former certificate
3 holder meets the applicable renewal requirements of subsections (c) through **[(f)](E)**
4 and **[(l)(1)(i)2] (K)(1)(I)2** of this section.

5 **[(i)] (H)** Subject to subsection **[(j)] (I)** of this section, the Board shall renew
6 the certificate of each nursing assistant or medication technician who meets the
7 requirements of this section.

8 **[(j)] (I)** (1) Within **[30] 60** days after a change has occurred, each
9 certificate holder shall notify the Board in writing of any change in a name or address.

10 (2) If the certificate holder fails to notify the Board within the time
11 required under this subsection, the Board may impose an administrative penalty of
12 \$25 on the certificate holder.

13 **[(k)] (J)** The Board shall pay any penalty collected under this subsection to
14 the General Fund of the State.

6 (a) If, during the **REVIEW OF AN APPLICATION FOR CERTIFICATION OR**
7 investigation of an allegation brought against a certified nursing assistant or certified
8 medication technician under this subtitle, the Board has reason to believe **AND**
9 **OBJECTIVE EVIDENCE** that the **APPLICANT**, certified nursing assistant, or certified
10 medication technician may cause harm to a person affected by the practice of the
11 **APPLICANT**, certified nursing assistant, or certified medication technician, the Board,
12 on its own initiative, shall direct the **APPLICANT**, certified nursing assistant, or
13 certified medication technician to submit to an appropriate examination by a health
14 care provider designated by the Board.

15 (b) In return for the privilege [given] to **PRACTICE AS** a certified nursing
16 assistant or certified medication technician [to practice] in the State, [the] **AN**
17 **APPLICANT**, certified nursing assistant, or certified medication technician is deemed
18 to have:

19 (1) Consented to submit to an examination under this section if
20 requested by the Board in writing; and

21 (2) Waived any legal claim of privilege as to the testimony or
22 examination reports of the examining health care provider.

23 (c) The failure or refusal of [a] **AN APPLICANT**, certified nursing assistant,
24 or certified medication technician to submit to an examination required under
25 subsection (b) of this section is prima facie evidence of the inability of the **APPLICANT**,
26 certified nursing assistant, or certified medication technician to competently practice
27 as a certified nursing assistant or certified medication technician, unless the Board
28 finds that the failure or refusal was beyond the control of the **APPLICANT**, certified
29 nursing assistant, or certified medication technician.

30 (d) The Board shall pay the cost of any examination made in accordance with
31 the provisions of this section.

32 SECTION 2. AND BE IT FURTHER ENACTED, That the State Board of
33 Nursing shall stagger the renewal of licenses required under § 8–312(a) of the Health
