1 (ii) This examination shall include the regulations adopted by 2 the Workers' Compensation Commission that are to be used by physicians to measure 3 impairment when preparing medical evaluations of claimants.

4 (2) The Committee shall review the adequacy and appropriateness of 5 all benefits specified in §§ 9–626 and 9–627(a) and (b) of the Labor and Employment 6 Article and make recommendations for necessary changes prior to the 1992 Regular 7 Session of the General Assembly.

8 (3) The Committee shall direct the Insurance Commissioner to 9 prepare a feasibility study on alternative methods to determine the provision for claim 10 payment and to submit the study to the Governor and the Legislative Policy 11 Committee on or before January 1, 1991.
