- (C) IF A RETIREE DIES BEFORE THE TOTAL AMOUNT OF RETIREMENT ALLOWANCE THE RETIREE WAS ENTITLED TO RECEIVE, INCLUDING ANY SUSPENDED ANNUAL RETIREMENT ALLOWANCE ADJUSTMENTS, EQUALS THE TOTAL AMOUNT OF RETIREMENT ALLOWANCE THE RETIREE WAS RECEIVING ON JULY 1, 2010, AND THE RETIREE HAS SELECTED AN OPTIONAL FORM OF ALLOWANCE UNDER TITLE 21, SUBTITLE 4 OF THIS ARTICLE, THE DECEASED RETIREE'S BENEFICIARY SHALL RECEIVE A BENEFIT CALCULATED ON THE RETIREMENT ALLOWANCE THE DECEASED RETIREE WAS ENTITLED TO RECEIVE AT THE TIME OF THE RETIREE'S DEATH AND NOT WHAT THE RETIREE WAS RECEIVING AT THE TIME OF THE RETIREE'S DEATH.
- SECTION 2. AND BE IT FURTHER ENACTED, That, in accordance with § 21–113 of the State Personnel and Pensions Article, the Board of Trustees of the State Retirement and Pension System is not required to recover any improper overpayment received by a retiree on or before July 1, 2010, if the retiree:

retired from the Employees' Retirement System or Employees' 1 (1) 2 Pension System on or before June 30, 2009; 3 before retirement was an employee of the Maryland School for the (2) 4 Deaf; and 5 before retirement, as an employee for the Maryland School for the (3) Deaf, was a 10-month employee incorrectly classified with the State Retirement 6 7 Agency as a 12-month employee. SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect 8 9 July 1, 2010.
