A BILL ENTITLED

1 AN ACT concerning

2 **Election Law – Voter Qualifications – Individuals Under Guardianship for**
3 **Mental Disability**

4 FOR the purpose of repealing the disqualification of individuals under guardianship
5 for mental disability from voting; and generally relating to voter qualifications.

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
12 MARYLAND, That the Laws of Maryland read as follows:

13 **Article – Election Law**

14 3–102.

15 (a) Except as provided in subsection (b) of this section, an individual may
16 become registered to vote if the individual:

17 (1) is a citizen of the United States;

18 (2) is at least 18 years old or will be 18 years old on or before the day
19 of the next succeeding general or special election;

20 (3) is a resident of the State as of the day the individual seeks to
21 register; and

22 (4) registers pursuant to this title.

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.



1 (b) An individual is not qualified to be a registered voter if the individual:

2 (1) has been convicted of a felony and is actually serving a
3 court-ordered sentence of imprisonment, including any term of parole or probation, for
4 the conviction; **OR**

5 (2) [is under guardianship for mental disability; or

6 (3)] has been convicted of buying or selling votes.

7 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
8 October 1, 2010.
