3 4 5	(i) Except as provided in [paragraph (6)] PARAGRAPHS (6) AND (7) of this subsection, no more than 12 winery special event permits are issued to the Class 4 Maryland limited winery in any given calendar year;
6	(ii) The permit does not exceed 3 consecutive days; and
